## **SECTION 708AA CLEANSING NOTICE – RIGHTS ISSUE**

For the purposes of section 708AA(2)(f) of the Corporations Act 2001 (Cth) (the “Corporations Act”) as modified by ASIC Corporations (Non-Traditional Rights Issues) Instrument 2016/84 (ASIC Instrument), ShareRoot Limited (the “Company”) hereby provides notice that on 23 January 2018 the Company announced the successful completion of the Rights Issue Shortfall (“Shortfall”). As the Shortfall was oversubscribed 162,936,288 additional shares were also issued to sophisticated and professional investors (Additional Shares”) at an issue price of \$0.005 per share.

In accordance with section 708AA(2)(f) of the Corporations Act, the Company gives notice that:

1. The Shortfall and Additional Shares will be offered for issue without disclosure to investors under Part 6D.2 of the Corporations Act as modified by the ASIC Instrument;
2. This notice is being given under section 708AA(2)(f) of the Corporations Act as modified by the ASIC Instrument;
3. As at the date of this notice, the Company has complied with:
  - i) The provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
  - ii) Section 674 of the Corporations Act;
4. As at the date of this notice, there is no excluded information of the type referred to in sections 708AA(8) and 708AA(9) of the Corporations Act as modified by the ASIC Instrument; and
5. The issue of the Shortfall and Additional Shares is not expected to have any material effect or consequence on the Company.
