Black Star Petroleum Limited ("BSP" or the "Company") is pleased to present the December 2017 quarterly report.

### **Activities/Corporate**

BSP currently holds leases under the Nebraska Oil Project covering 1,093.2 acres under its subsidiary, Constellation Resources LLC. The Board is still considering its options with the Nebraska Oil Project as well as considering other various recapitalisation strategies and opportunities.

### **Finance**

During the quarter, BSP drew down another \$10,000 from the \$500,000 unsecured loan facility with Mr Chin Han Tan, a Sydney based investor ("Lender"). As at 31 December 2017, a total of \$464,000 has been drawn down.
