STRATEGIC REVIEW AND RESIGNATION OF EXECUTIVE DIRECTOR AND CHIEF FINANCIAL OFFICER

The Board of Directors (the "Board") of Digimatic Group Ltd. ("DMC" or "the Group") wishes to advise that it will be undertaking a strategic review of all the divisions within the Group's businesses to assess the synergies between the digital marketing and newly acquired financial education operations (8VIC Global Pte Limited ("8VIC")) for optimal business performance.

Resignation of Executive Director and Chief Financial Officer

The Company advises that Mr Ivan Ong has resigned, effective today, as the Director of DMC to focus on the business operations of Digimatic Media Pte Ltd (DMM), a 100% subsidiary of DMC. Ms Chung Pit Lee has also confirmed her resignation as CFO of the Group to pursue other career opportunities. Ms Chung's resignation will take effect on 28 February 2018.

Mr Ivan Ong will remain in the group in the capacity of Managing Director of DMM, focusing on driving the growth of this subsidiary.

Ms Pauline Teo, who is the Executive Director of the Group, has been nominated with immediate effect, as the Board's representative, to manage the strategic review. It is expected the strategic review will be completed within two to three months.





Mr Adrian Lim has been appointed as acting Chief Financial Officer ("CFO") with effect from 1 March 2018. Adrian is the Financial Controller of 8VIC and has 15 years of experience in mergers & acquisitions, private equity houses advisory, transaction services, and valuations & financial modelling. Prior to his role in 8VIC, Adrian had taken on the roles of CFO and Director in multiple companies.

"On behalf of the Board, I would like to thank Pit Lee for her contributions to the Group during her tenure with DMC and wishes her well in her future endeavor", commented Mr Clive Tan, Non-Executive Chairman of the Group, "I would also like to thank Ivan for his contribution as Executive Director and acknowledge his commitment to DMM's business operations."
