## Extension to convening period for second meetings of creditors

Scott Langdon, John Bumbak and Richard Tucker of KordaMentha were appointed as Administrators ('the Administrators') of the Group on 20 January 2018. Subsequent to the appointment of the Administrators, the Group's secured noteholder appointed Jason Preston, Shaun Fraser and Robert Brauer of McGrathNicol as Receivers and Managers ('the Receivers') of the Group on 23 January 2018.
