**ISSUE OF ORDINARY SHARES - NOTICE IN ACCORDANCE WITH SECTION 708(A)

Sandfire Resources NL (ASX: **SFR**, or the **Company**) advises that 166,006 and 41,502 new fully paid ordinary shares (**New Shares**) have been allotted and issued to Auris Minerals Limited and Fe Limited respectively, as consideration for the acquisition of exploration tenements.
