WA Salt Koolyanobbing - Letter Of Intent Evaluate Sodium Chloride (NaCl) Salt Products

Highlights

- Kalium Lakes Limited has signed a **Letter of Intent** with **WA Salt Koolyanobbing** to evaluate recovery of Sodium Chloride (NaCl) salt products at the Beyondie Sulphate Of Potash Project.
- The recovery of a high grade NaCl product has the potential to generate additional revenue for the Beyondie Sulphate Of Potash Project.

Kalium Lakes Limited (KLL) announced today that it has signed a Letter of Intent (LOI) with WA Salt Koolyanobbing Pty Ltd, part of the WA Salt Group (WA Salt), to evaluate and assess the recovery of Sodium Chloride (NaCl) salt products from the Beyondie Sulphate Of Potash Project (BSOPP) in Western Australia.

The WA Salt Group, which produces high quality salt products for domestic and international customers, will work with Kalium Lakes to determine which types of NaCl products can be recovered from the BSOPP and may be suitable for both local and international markets.

KLL is currently conducting trials at its Large Scale Pilot Evaporation Ponds which have produced more than 3,000 tonnes of NaCl salts. Test results from initial samples show sufficiently high NaCl concentrations to continue the testing of larger, bulk samples. This additional testing is currently underway.

Lelio Gaudieri, WA Salt Group's Chief Executive Officer, said: "We see this LOI as the first step in an assessment that could deliver benefits for both our businesses. A reliable source of high quality NaCl could potentially represent an attractive commercial opportunity."

KLL's Chief Development Officer, Rudolph van Niekerk, commented: "We continue to explore partnerships and opportunities generated by each stage of the SOP production process and the initial discussions with WA Salt have been positive. If this evaluation translates into a viable business case, what is essentially a by-product that would go to waste could contribute additional revenue for the Beyondie Sulphate Of Potash Project," he said.

Kalium Lakes Limited is an exploration and development company, focused on developing the Beyondie Sulphate Of Potash Project in Western Australia with the aim of producing Sulphate of Potash (SOP) for the domestic and international markets.

The Beyondie SOP Project comprises 15 granted exploration licences and a miscellaneous licence covering an area of approximately 2,400 square kilometres. This sub-surface brine deposit will supply an evaporation and processing operation located 160 kilometres south east of Newman.

The results of the Pre-Feasibility Study, announced on 3 October 2017, confirmed that the Project is technically and financially robust.

The Company is also a Joint Venture partner with BC Iron Limited (BCI) in the Carnegie Potash Project, a potash exploration project located approximately 220 kilometres north-east of Wiluna. Carnegie comprises one granted exploration licence and two exploration licence applications covering a total area of approximately 1,700 square kilometres.
