Copper Mountain Mining Corporation – Admission and Commencement of Official Quotation

## Description

On 20 November 2017 Altona Mining Limited ("Altona") announced that Altona and Copper Mountain Mining Corporation (the "Company") had agreed to undertake a scheme of arrangement under section 411 of the Corporations Act ("Scheme") pursuant to which the Company would acquire the entire issued capital of Altona.

Under the Scheme, the Company will be admitted to the official list of ASX and Scheme Shareholders (as defined in the Scheme documentation) will receive for each fully paid ordinary share held in Altona 0.0974 Company common shares to be settled in the form of CHESS depositary interest ("CDIs").

On 27 March 2018, Altona announced that its shareholders had approved, amongst other things, the Scheme.

On 3 April 2018, the Federal Court approved the Scheme. The Court orders were lodged with ASIC on 4 April 2018.

The Company is admitted to the Official List of ASX Limited ("ASX") on Thursday, 5 April 2018.

Official quotation of the CDIs is expected to commence on a deferred settlement basis at 12:30 pm AEST (10:30 am WST) on 6 April 2018.
