

\$2.3M Miracle Valley Order

RotoGro International Limited ("ASX:RGI", "RotoGro" or the "Company") refers to the announcement made on Wednesday April 4, 2018 ("RotoGro Secures \$2.3M Order from Miracle Valley" or the "Announcement") for a \$2.3M Purchase Order (the "Order") from Miracle Valley Medicinal Alternatives M.V.M.A. Ltd. ("Miracle Valley"). The Announcement stated that Miracle Valley was a Health Canada Licensed Producer.

RotoGro wishes to clarify that Miracle Valley has applied for; and is in the final stages of obtaining an authorised license to produce cannabis for medical purposes. Miracle Valley are entering the buildout phase of their facility for which the RotoGro Hydroponic Gardens are required for buildout signoff and Issuance of a License to Produce.

The Order with Miracle Valley is binding and unconditional, and RotoGro has received an initial deposit for the Order. RotoGro and Miracle Valley have agreed first delivery will commence at the end of this quarter (which will represent approximately 30% of the Order) with deliveries continuing on a room by room basis through the second half of 2018 as Miracle Valley advance their license through Introductory Inspection (as cultivation begins) to a License to Sell.
