Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Volt Resources Limited (ASX:VRC) (“the Company”) issued 69,890 fully paid ordinary shares on 9 April 2018. These shares were included in an Appendix 3B announcement to the Australian Securities Exchange (“ASX”) released today.
