

SECTION 708A CLEANSING NOTICE

This notice is given by SRG Limited (SRG) under section 708A(5)(e) and 708A(6) of the Corporations Act 2001 (the Act).

SRG issued 25,000 fully paid ordinary shares on 9th of April 2018 and 50,000 fully paid ordinary shares on 11th of April 2018 (ASX Code: SRG) pursuant to the exercise of options with an exercise price of \$0.835 per share.
