### **COMPLETION OF PLACEMENT**

The Company has completed the placement of ordinary shares and issue and allotment of 10,157,143 ordinary shares at \$0.175 each to raise \$1,777,500 ("**Placement**").

Subject to shareholder approval, Toby Chandler or his nominee will apply for A\$250,000 and Gary Steinepreis or his nominee will apply for A\$100,000 ("**Related Parties**") as part of, and on the same terms, as the Placement.

### **ISSUE OF EMPLOYEE INCENTIVE OPTIONS UNDER INCENTIVE OPTION PLAN**

The Company has completed the issue of a total of 135,000 employee incentive options exercisable at 29.5 cents on or before 2 January 2023, which are subject to vesting and employment conditions. The options vest in 1/3<sup>rd</sup> tranches of 45,000 annually commencing on 2 January 2018.
