

QUARTERLY ACTIVITIES REPORT FOR THE PERIOD ENDED 31 MARCH 2018

HIGHLIGHTS

Atrum Coal Ltd (“**Atrum**” or the “**Company**”) (**ASX: ATU**) is pleased to provide its Quarterly Activities Report for the period ending 31 March 2018.

Non-Executive Chairman Charles Blixt commented: *“Our focus during the quarter has been on raising funds through share placements and closing the acquisition of the Elan hard coking coal project in Alberta, Canada. Both have been completed successfully. We will now be undertaking some major exploration at Elan Coal during 2018, with a focus on the Elan South area. We look forward to starting the field work in June and to keeping the market updated on our progress.”*

The first quarter of 2018 showed minor changes in prices of coking coals, while anthracite prices have remained stable. (see price charts below from Resource-Net).




Figure 1: Coking Coal Price Chart




Figure 2: Anthracite Price Chart

Elan Project Update

Elan Coal Ltd. Acquisition Completed

Atrium Coal Ltd. acquired 100% of Elan Coal Ltd. in late March, 2018. The Elan Coking Coal properties in Southern Alberta, Canada have six areas known to hold shallow emplacements of high quality hard coking coal. The Elan South project, one of six distinct project areas in Elan, is adjacent and contiguous with the Riversdale Resources Ltd.'s Grassy Mountain project, and close to critical infrastructure for development.

Elan South Project Receives Coal Exploration Permit

Elan Coal Ltd. received a Coal Exploration Permit in March allowing the field exploration to be carried out in the Elan South project area. An extensive drilling program is planned from June to August 2018 and includes a Large Core Diameter (LDC) coring program to better understand the coal quality characteristics of Elan South. Large sample masses are expected to be obtained from the LDC program for various testing, with washability and coke strength after reaction (CSR) two of the key properties of significant interest to Atrium.

During the quarter, the Company continued the finalisation of the upcoming Elan South drilling and exploration program planned for June, July, and August 2018.

Objectives of the Elan South drilling and exploration program included:

- Further define and expand on the current Elan South JORC Resource Estimate

- Identify additional coal surface exposures
- Verify geological model predictions and historic surface data
- Begin acquiring environmental baseline data in the project area

The Company continued discussions with potential partners/investors to jointly explore and develop the Elan properties.

Panorama North Anthracite Project




Figure 3: Drillholes and Trenches at Panorama North.

During and subsequent to the quarter, the Company finalised the preliminary geology and coal report on the Panorama North drilling campaign completed in 2017; Figure 3 illustrates the drill holes completed to date by the JV Exploration Agreement. Results from the 2017 program are encouraging and will help guide the proposed 2018 drilling and mapping efforts. After reviewing the 2017 results and the 2018 proposed exploration plans, Japan Oil, Gas and Metals National Corporation ("JOGMEC") committed to the third year of the JV Exploration agreement. The Panorama North Project is made up of 12 titles and covers an area of 74 Km². (Please see Tenement summary at the end of this report)

Groundhog Anthracite Project

The Groundhog Anthracite Project (Groundhog) is in the Groundhog Coalfield in north-western British Columbia, Canada. Atrum’s current Groundhog tenements consist of 59 titles and cover an area of approximately 553 km² (Please see Tenement summary at the end of this report). Groundhog is prospective for high grade and ultra-high-grade anthracite suitable for use in the manufacture of blast furnace steel, as well as electric arc furnaces, as a reductant, filter media, and feedstock for chemical production.

During and subsequent to the quarter, the Company continued discussions with potential joint venture partners for future exploration and development of the Groundhog areas. The Company will update shareholders when progress is made to secure additional Joint Venture Partners for Groundhog.




Figure 4: The Company’s current coal licences at the Groundhog and Panorama Project areas.

In an effort to reduce costs to the Groundhog project, the Company relinquished non-core coal licences. The licences that were released were not part of either the Groundhog North project or the Panorama North project. A current map of the Company’s coal licences in the Groundhog Coalfield can be seen in Figure 4. Cost savings are estimated to be around \$50K per annum. A further study is being carried out in relation to some of the other non-core areas.

Atlantic Carbon Group PLC

During the quarter ended 31 March 2018, the Company recovered \$160K from Atlantic Carbon Group PLC (ACG) and a further \$160K in April 2018 with respect of the inventory held. The carrying value of the inventory after the payment in April has reduced to USD 980K.

CORPORATE

Financing Placement

During the quarter the Company announced and completed a placement of 80,000,000 shares at A\$0.10 for an amount of A\$8M, of which 30,500,000 shares were issued during the quarter and the balance will be issued after the AGM scheduled for the 31st of May. The proceeds of the placement were used as cash consideration for 100% interest in Elan project acquisition, in Alberta Canada. A further 19,690,490 shares, valued at \$3.65M, were issued to the vendors of the Elan project for the non-cash consideration.

During the quarter, 7,500,000 shares at a share price of \$0.10, were issued to the Kuro Convertible note holders who opted, further to an offer made during the quarter, to redeem their note against Atrum shares.

The Company announced an Entitlement Issue to eligible shareholders for one new share for every 5 held at a price of \$0.10 per share. The Company expects to raise around \$2M from the Entitlement Issue.

Other Items

Joint Venture – Panorama Project

JOGMEC has earned in 21% interest in the Panorama project, after spending \$3.1M in exploration at the site. The Joint Venture is expected to complete a program of \$1.89M in 2018, at which point JOGMEC will earn in 35% of the project.
