

MT REMARKABLE DRILLING UPDATE

Australian Securities Exchange Announcement 30/04/18

Mt Remarkable Drilling Commences this Week

The Board of King River Copper Ltd (ASX:KRC) advise that appraisal drilling of the Mt Remarkable gold discovery is now expected to commence on or about May 4 due to a drill rig mechanical issue.

Down hole surveys of previous high grade intersections were completed last week to better constrain the location of the gold mineralisation.




Figure 1: – Long Projection of the Trudi Vein main prospect area showing previously reported 2017 drill results and interpretive contours of mineralisation in gram-metres, and location of close spaced drilling planned for 2018. Modified from Figure 2 of KRC ASX announcement 20/12/17.

A drilling pattern of close spaced holes has been designed to test the vertical extent of the Trudi Vein intercepts (Figure 1) where the previously reported scissor hole returned 11metres at 27.9g/t Au (KRC ASX announcement 27/11/17).




Figure 2: - Long Projection of the Trudi Vein main and extension areas showing planned 2018 drill holes. Modified from Figure 3 of KRC ASX announcement 20/12/17.

Drilling is 2017 has extended the main Trudi vein system to a potential strike length of nearly 1km with mineralised intersections obtained 600m to the east and 100m to the west of the original historical drilling (refer KRC ASX announcement 20/12/17). Numerous exploration holes will be drilled along that structure over the coming 6 weeks (Figure 2).
