Appendix 3B – Late Lodgement

Please find attached an Appendix 3B for Alterra Limited. The Appendix 3B covers the issue of 4,000,000 unquoted options at \$0.035 expiring on 31 March 2021 on 2 March 2018.

Alterra notes that the appropriate disclosure was made to the ASX in relation to the issue of unquoted options at the correct time via ASX announcement 335 on 5 March 2018, however, the relevant Appendix 3B was not lodged.

While Alterra considers its current arrangements are adequate for ensuring timely and accurate notification, and the failure to do so on this occasion was due to an administrative oversight, it has nevertheless reviewed its procedure to ensure that it meets its ongoing disclosure obligations.

The Company's current capital structure is as follows:

- 143,599,988 Listed fully paid ordinary shares
- 3,000,000 Unquoted options at \$0.06 expiring 31 May 2018
- 6,000,000 Unquoted options at \$0.15 expiring 1 March 2019
