1) The JV has an agreement with Blue Capital Services Pty Ltd to fund mining costs up to a maximum of A\$7.5 million of which \$877k is outstanding at quarter end. The JV owes a facility fee for the cost of finance of \$4.0 million (These balances relate to 100% of the JV - ERL owns 60%).

2) Unsecured loan includes an advance from a Director (\$335k - coupon interest rate equivalent to the Australian Government Bond 2 year yield). There are no fixed terms for repayment.
