NSL Phase 3 Expansion Update

HIGHLIGHTS

- Essar Projects Limited engaged for all detailed engineering and design work on expansion of the Kurnool plant
- In addition, Essar engaged for project delivery, and has established a fully resourced Project Management Office consisting of 7 specialist engineers on the Phase 3 expansion, with project work now in full flow
- NSL appoints full-time Phase 3 expansion Project Manager with extensive overseas experience, Mr John Clayton
- Phase 3 expansion targeting increased production to ~400,000 tpa while delivering significantly improved grades and yields; commissioning scheduled for H1 2019

NSL Consolidated Limited (ASX: NSL) ("NSL" or "the Company") is pleased to provide an update on the Phase 3 expansion ("the Expansion") of the Company's Kurnool wet beneficiation plant in India.

As previously advised (see ASX release dated 14^{th} May 2018), the Expansion is scheduled for commissioning in H1 2019, after which time NSL expects to achieve an annualised production rate of $\sim 400,000$ tpa.

To achieve improved plant performance, NSL will invest significantly in several key areas to provide higher certainty regarding the project expansion outcomes, including;

- The purchase of additional large-scale equipment, with long lead items expected to be ordered in coming weeks;
- Implementation of improved process and control technologies and equipment;
- Appointment of additional highly experienced project management staff;
 and
- Appointment of Tier One engineering, design and project management expertise.

Appointment of experienced Project Manager

NSL is pleased to advise that Mr John Clayton has been appointed as Project Manager to oversee the Expansion, based in India.
