

## MIKE BAILEY JOINS VEEM BOARD AS NON-EXECUTIVE DIRECTOR

Mr Bailey has the degree of Master of Science in Naval Architecture, Post Graduate Diploma in Ocean Engineering, and a Bachelor of Science in Mechanical Engineering. He is a Chartered Engineer (UK), Member of the Royal Institution of Naval Architects, and a former Member of the Royal Corps of Naval Constructors (1968-78).

Mr Bailey's appointment follows the appointment of Mr Peter Torre in April 2018 and further enhances VEEM's Governance Framework. Whilst Mr Bailey was previously employed by the Company, he has not acted in any capacity for the Company for in excess of 20 years, and as such, is considered by the Board of the company to be an Independent Non-Executive Director.
