



Section 708A(5)(e) cleansing notice

On 18 July 2018, Emu NL (**Company**) issued 4,894,330 fully paid ordinary shares to subscribers to a placement as described in the appendix 3B announced earlier today (together the **Securities**).

Subject to the foregoing and to the extent applicable, the Company hereby notifies ASX under paragraph 708A(5)(e) of the Corporations Act 2001 (**Act**) that:

- (a) the Company issued the Securities without disclosure to investors under Part 6D.2 of the Act;

 - B. the rights and liabilities attaching to the Securities.
