Conversion of Final Tranche of Director's 2016 Performance Rights & Partial Release of Restricted Securities

MGC Pharmaceuticals Ltd (**Company**) wishes to advise that pursuant to the announcement on 30 January 2018 regarding the satisfaction of the milestones of 36,500,000 Performance Rights, the Company advised at the time that 10,000,000 of these vested Performance Rights would be converted to ordinary shares at a later date, at the election of the holder being the Executive Chairman Mr Brett Mitchell. The Company has now received instruction from the Chairman for the vested Performance Shares to be converted to Ordinary Shares in the capital of the Company following the achievement of Milestone 1 and 2, as first announced to the market on 30 January 2018, and the recent granting of full GMP certification and manufacturing license for the Company's leading European medicinal cannabis manufacturing facility.

In addition, the Company advises that it has agreed to release 347,542 ordinary shares from a voluntary holding lock (VHL) relating to the original acquisition terms of Erin Resources Limited, from the original transaction in 2013.
