SHORTFALL ISSUE - NON-RENOUNCEABLE ENTITLEMENT ISSUE


Metalsearch Limited (“Company”) is pleased to advise that it has issued a further 65,428,521 ordinary fully paid shares (**Shares**) pursuant to the non-renounceable entitlement issue offer dated 6 June 2018. The issue of Shares represents the shortfall from the entitlement issue and raised a further \$654,285 to bring the total raising to \$1,529,700.

In accordance with the ASX Listing Rules, the shortfall Shares were issued on the same terms as the Shares issued under the entitlement issue.

An Appendix 3B for the issue of Shares is attached.

Due to the level of interest from sub-underwriters to the entitlement issue, the Company has resolved to issue a further 220,000,000 Shares on the same terms as the Shares issued under the entitlement issue to raise an additional \$220,000. The placement will be made under the Company’s available placement capacity under ASX Listing Rule 7.1. An Appendix 3B for this further issue will be lodged on completion of the issue.
