The loan facilities include:

- 1) 450 convertible notes at an issue price of \$10,000 each, convertible to equity at any time at 4.0 cents per share and pay an 8.0% p.a. coupon; and
- 2) \$1.8 million in unsecured convertible notes from the Australian Renewable Energy Agency Emerging Renewables Program. \$1.6 million has been drawn down to date. The notes can convert to equity at 5.3 cents per share and do not pay an interest coupon.
- 3) 50% share of \$7.5 million in construction debt financing with Asymmetric Credit Partners Pty Ltd for the construction of the 10MW Northam Solar Farm. This debt has been fully drawn down and was novated to the Northam Solar Farm Partnership in April 2018.
- 4) \$4m in a revolving debt facility to support research and development activities (\$0.8m drawn down) and a \$2.1m debt facility for post-construction debt refinancing of the Garden Island Microgrid. Both facilities are with the Commonwealth Bank of Australia.

Government funding consists of \$30.5 million across:

- two grants from the Australian Renewable Energy Agency Emerging Renewables Program,
- one grant in the UK for the WaveHub project,
- one grant from the Western Australian State Government,
- one grant from the National Energy Resources Australia, and
- one grant from the Renewable Technology Fund.
