### **NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Cth)**

This cleansing notice (Cleansing Notice) is given by Pioneer Resources Limited (ASX:PIO) (ACN 103 423 981) (Company) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act).

The Company advises that it issued 66,666 fully paid ordinary shares (Shares) on 1 August 2018 upon the exercise of 66,666 ASX:PIOO options, which expired on 31 July 2018.

For the purposes of section 708A(5)(e) of the Corporations Act, the Company gives notice that:

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) as a disclosing entity, the Company is subject to regular reporting and disclosure obligations;
