**Issue of Securities - Cleansing Statement**

On 2 August 2018 Peppermint Innovation Limited (the 'Company') placed 12,333,334 ordinary shares at 3 cents per share to sophisticated and professional investors. The issue completes 67% of the funds to be raised under an agreement with Smidge Digital Unit Trust (or its nominees) ("Smidge"), to place shares to the value of \$1 million with strategic investors.

The Company hereby gives notice that:

The shares were issued within the available limit under ASX Listing Rule 7.1.
