## SIMPEC Awarded \$1M Mechanical Installation Contract

### Highlights:

- WestStar business **SIMPEC Pty Ltd** has been awarded a **~\$1M** contract in Henderson, Western Australia

With recent awards (refer to ASX announcements of 4 July 2018 and 17 July 2018) and the new Mechanical Package Contract, SIMPEC has added \$6 million of work to its order book. During the past six months, SIMPEC has tendered for more than \$150 million of work and will continue to tender for projects throughout Australia.
