

## **SECTION 708A CLEANSING NOTICE**

This notice is given by SRG Limited (SRG) under section 708A(5)(e) and 708A(6) of the Corporations Act 2001 (the Act).

SRG issued 200,000 fully paid ordinary shares on 13th of August 2018 (ASX Code: SRG) pursuant to the exercise of options with an exercise price of \$0.827 per share. The options were issued to Michael Atkins following shareholder approval at the 2014 Annual General Meeting.
