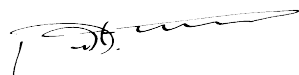
NOTIFICATION UNDER SECTION 708A(5)(E)

On 14 August 2018 respectfully Canyon Resources Limited ("CAY" or "the Company") issued 325,000 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 15 August 2018.
