## **EXTENSION TO RIGHTS ISSUE OFFER PERIOD**

On 10 August 2018 Inca Minerals Limited (Inca or Company) mailed a Prospectus containing an Entitlement Offer to Eligible Shareholders (Offer). However, as of today's date, the Company continues to receive queries from Inca shareholders who wish to take up entitlements under the Offer, but who have not received their Offer documents.
