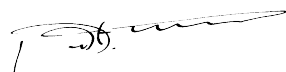
NOTIFICATION UNDER SECTION 708A(5)(E)

On 22 August 2018 Canyon Resources Limited ("CAY" or "the Company") issued 460,000 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 23 August 2018.
