NOTIFCATION UNDER SECTION 708A(5)(E)

On 19 September 2018 Canyon Resources Limited ("**CAY**" or "the Company") issued 2,433,333 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 20 September 2018.
