Change of Share Registry Details

Acrow Formwork and Construction Services Limited (ASX:ACF) ("Acrow" or the "Company") advises that as of Monday, 24th September 2018, it has changed its provider of shareholder registry services from Link Market Services Limited to Automic Registry Services (Automic).

Shareholders can easily and efficiently manage their holdings via Automic's secure and highly accessible online Investor portal. The portal provides among other things an online interface to update and manage shareholder details, view balances and transaction history.

Shareholders that are not already a user of Automic's Investor portal may visit <https://investor.automic.com.au> and signup to register their details using the two simple steps provided in the setup process.

Acrow's Upcoming Dividend

Shareholders are reminded that on 28 August 2018 Acrow declared an unfranked dividend of 0.5 cents per share to be paid on 22 October 2018 to holders on the Company's fully paid ordinary share register on 28 September 2018 (Record Date).

The Company also announced the implementation of a Dividend Reinvestment Plan (DRP). Eligible holders choosing to participate in the DRP will be issued DRP shares at a 2.5% discount to the Market Value. The Market Value is the arithmetic average of the daily volume weighted average sale price for a Share (rounded to four decimal places) sold through a Normal Trade on ASX on the ten trading days commencing on the second trading day following the Record Date.

To ensure receipt of your dividend either by DRP shares or direct credit, shareholders are encouraged to ensure that their DRP election preference, bank details and TFN/ABN are up to date with Automic by the Record Date. This can be done online by following the steps above.
