## **Binding MoU Agreement signed with OECS**

### **Highlights**

- Binding Memorandum of Understanding agreement signed with OECS (The Organization of Eastern Caribbean States), an International Inter-governmental Organization in the Eastern Caribbean
- The agreement confirms the ongoing negotiations for the provision of SAS' network services to the region and symbolises the ability for the Company to leverage existing regional relationships for commercial operations in the region
- MoU stipulates a mutually agreed commitment by OECS to satisfy a minimum number of devices and services
- Supports SAS' global growth strategy, further validates its proprietary communication platform capabilities and symbolises its ability to satisfy the needs of various types of organisations in remote areas

Sky and Space Global Ltd (**ASX: SAS, "Sky and Space Global" or "the Company"**) is pleased to announce it has signed a binding Memorandum of Understanding (MoU) agreement with OECS (The Organization of Eastern Caribbean States).

The OECS is an international inter-governmental Organisation dedicated to establishing a single financial and economic space within which goods, people and capital move freely, monetary and fiscal policies are harmonized and member states continue to adopt a common approach to trade, health, education and the environment, as well as to the development of such critical sectors as agriculture, tourism and energy.

The Eastern Caribbean is comprised of Antigua and Barbuda, Commonwealth of Dominica, Grenada, Montserrat, St. Kitts and Nevis, Saint Lucia, St Vincent and The Grenadines, British Virgin Island, Anguilla and Martinique.

Under the terms of the MoU, SAS and OECS will collaborate to explore how SAS' connectivity platform can be incorporated into the communication infrastructure of OECS member states, to improve and enhance its reliability, accessibility and feasibility. The MoU stipulates a mutually agreed commitment by OECS to satisfy a minimum number of devices and services, and also includes the option to increase the number of devices and services required to meet OECS' needs.

The signing of this MoU agreement supports the SAS business model of providing connectivity to equatorial locations and becoming a leading global player in the nano-satellite market.

**Sky and Space Global's Managing Director and CEO, Mr. Meir Moalem said:**

"I am delighted to report that we have leveraged our existing relationships in the Caribbean and signed an agreement with OECS. Over the last months we have focused on demonstrating our capabilities and building traction in this region, and our efforts have been fruitful."

The Organization of Eastern Caribbean States (OECS) is an International Inter-governmental Organization dedicated to economic harmonization and integration, protection of human and legal rights, and the encouragement of good governance among independent and non-independent countries in the Eastern Caribbean.

The Organization came into being on June 18th 1981, when seven Eastern Caribbean countries signed a treaty agreeing to cooperate with each other and promote unity and solidarity among the Members. The Treaty became known as the Treaty of Basseterre, so named in honour of the capital city of St. Kitts and Nevis where it was signed.

The OECS is now a ten-member grouping comprising the full Member States of Antigua and Barbuda, Commonwealth of Dominica, Grenada, Montserrat, St Kitts and Nevis, Saint Lucia and St Vincent and the Grenadines, with the British Virgin Islands, Anguilla and Martinique as associate members of the OECS.
