Letter from the Chairman

Dear Fellow Shareholders,

On behalf of your Board of Directors, I have pleasure in presenting the 2018 Annual Report and Financial Statements of Australian Vanadium Limited ("AVL" or the "Company") for the 30 June 2018 financial year.

The last 12 months have seen the Company achieve major milestones in its efforts to bring its flagship Gabanintha vanadium project in Western Australia closer to development, successfully positioning the Company as an Australian leader in a growing Vanadium sector as it seeks to take advantage of the significant rises in global vanadium prices to transform into the world's next vanadium producer.

In addition to a resource upgrade at Gabanintha, important achievements include concluding the Company's first Memorandum of Understanding with Chinese vanadium carbon nitride producer Win Win Corporation, the appointment of key vanadium experience into the AVL team and seeing significant growth in the Company's share price and market capitalization. These have cemented AVL's Gabanintha Project as a world-class vanadium resource in size, quality and grade with excellent prospects for further development. The updated mineral resource now comprises 175.5Mt at 0.77% vanadium pentoxide (V_2O_5), made up of a Measured Mineral Resource of 10.1Mt at 1.11% V_2O_5 , an Indicated Mineral Resource of 24.0Mt at 0.63% V_2O_5 , and an Inferred Mineral Resource of 141Mt at 0.77% V_2O_5 .

The identification of a cobalt-nickel-copper by-product opportunity from sulphide minerals contained in the Gabanintha mineralisation has been another highlight of the year's work, further differentiating the project from other vanadium projects emerging on the ASX during the year.

The Mineral Resources provided strong support for commencement of a Pre-Feasibility Study during the year, advancing the project towards detailed feasibility in 2019.

The growing team at AVL has also been advancing key activities in the areas of environmental approvals and negotiations with Native Title groups. These steps will ensure the all-important environmental and community support for the timely approval of a mining lease over Gabanintha.

The ongoing shortage of supply, and consistently increasing demand for vanadium in steel products, coupled with the rapidly growing needs of vanadium energy storage applications has seen vanadium prices increase from US\$2.50/lb V_2O_5 in November 2015 to over US\$20/lb V_2O_5 in September 2018, approaching a tenfold increase. An ongoing level of higher pricing and demand will be highly supportive of the Company's efforts in moving the Gabanintha project towards development in the shortest possible timeframe.

I wish to thank shareholders for their continuing support throughout the year and extend my sincere thanks to the Board, management and staff for their contributions and efforts.

Directors' Report

CORPORATE HIGHLIGHTS

The past year has seen Australian Vanadium Ltd make progress in its key strategic areas. A summary of key events follows:

Gabanintha Vanadium Project

- An updated Measured, Indicated and Inferred Mineral Resource was announced, comprising of 175.5 million tonnes (Mt) at $0.77\% \ V_2O_5$ which includes a discrete high-grade zone containing 93.6 million tonnes at $1.00 \% \ V_2O_5$ in Measured, Indicated and Inferred Categories. The discrete high-grade zone is currently the primary focus of economic studies at Gabanintha.
- Metallurgical testwork identified sulphide concentrations of cobalt, nickel and copper in the nonmagnetic tailings stream. Follow-up testwork has confirmed that a by-product of cobalt, nickel and copper sulphide concentrate can be produced with potential to increase revenue at Gabanintha.
- Pre-Feasibility Study (PFS) work has been ongoing throughout the year, with a base case released during September 2018.
- Definitive ore concentrate test work nearing completion. Inputs to be applied to flow-sheet design and PFS mining and processing studies.
- Environmental base line sampling surveys completed. Information to form part of future Environmental Impact Assessment and mining development proposal.
- A proposed Mining Agreement has been prepared and submitted to the Native Title group for consideration.
- Metallurgical test work results confirmed the Company's view that Gabanintha will be able to supply high quality V_2O_5 products to meet the needs of energy storage and steel making customers.
- Appointment of key technical consultants, external and internal
- MoU signed with Chinese steel and alloy product company Win-Win Development Group for potential finance of vanadium offtake.

VSUN Energy

- Residential vanadium energy storage system review completed, Company to focus on sale of imported systems while evaluating advances in component technology.
- Residential flow battery from SCHMID Energy Systems (Germany) for off-grid sites now available for order.
- Exclusive Dealership Agreement with Gildemeister terminated allowing VSUN Energy to market full range of Vanadium Redox Flow Battery (VRFB) systems from multiple vendors.
- Vanadium Redox Flow Battery (VRFB) sales expanded to include new products from other suppliers, offering greater flexibility of pricing and sizing for potential customers.
- Registrations of interest submitted to both Western Power and Horizon Power.
- Appointment of graduate Energy Data Modeller to support technical battery modelling and sales

Blesberg Project, South Africa

- Drilling was completed at Blesberg, results indicate localised development of low-grade LCT mineralisation.
- Extensive pegmatite development containing high quality and proportion of glass/ceramic quality microcline feldspar identified from drilling.
- Project deal re-negotiated around feldspar development.

Bryah Resources Limited

• Secured a 13.3% holding in Bryah Resources Limited, which successfully listed on ASX in October 2017.

Corporate Matters

- Appointment of China focused commodity and marketing consultant Mastermines.
- \$5,505,000 raised through placements.

REVIEW OF OPERATIONS

Gabanintha Vanadium Project

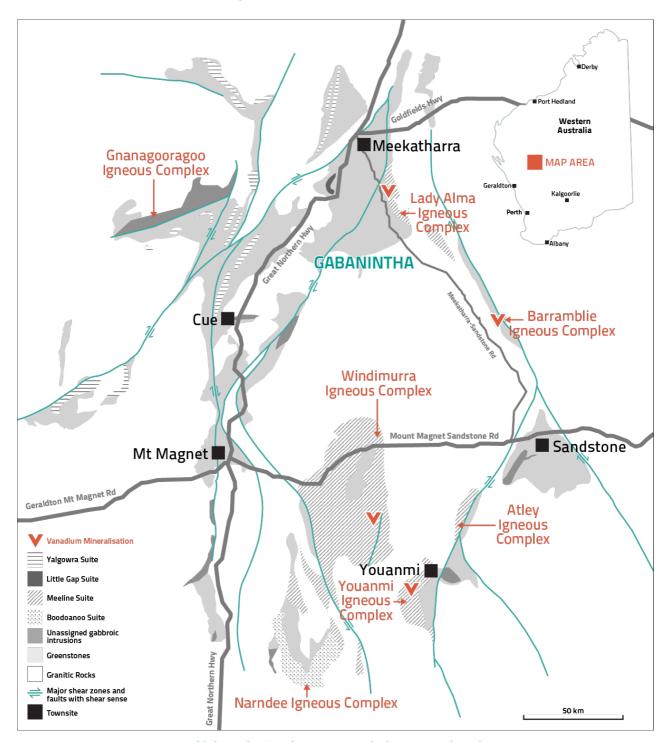


Figure 1 - Location of Gabanintha Vanadium Project and adjacent vanadium deposits

The Gabanintha Vanadium Project is located approximately 40km south of Meekatharra within the northern Murchison region of Western Australia. Access from Perth is via the Great Northern Highway and the Meekatharra-Sandstone Road (Figure 1).

The following is a summary of activities undertaken on the Gabanintha Vanadium Project during the period up to the date of this report.

Mineral Resource Estimates

An upgraded Measured, Indicated and Inferred Mineral Resource was estimated, comprising of 175.5 million tonnes (Mt) at $0.77\% \, V_2O_5$ which includes a Measured and Indicated Mineral Resource of 34.1Mt at $0.77\% \, V_2O_5$.

The revised Mineral Resource estimate includes a geologically distinct massive vanadium bearing magnetite high-grade zone that is the focus of ongoing economic studies. The Measured, Indicated and Inferred Mineral Resource estimate for the high-grade zone is 93.6Mt at 1.00% V_2O_5 which includes 10Mt at 1.11% V_2O_5 in the Measured Resource category, 4.9Mt at 1.09% V_2O_5 in the Indicated Resource category and 78.6Mt at 0.98% V_2O_5 in the Inferred Mineral Resource category.

The company identified significant concentrations of cobalt, nickel and copper in mainly sulphide minerals in the non-magnetic fraction of previous metallurgical test work. Estimation of cobalt, nickel and copper content follows bench scale test work and generation of sulphide flotation concentrates containing 3.8% - 6.3% base metals including 1.54% - 2.02% cobalt, 1.36% - 2.58% nickel and 0.82% - 1.70% copper. This indicated potential for the sale of a cobalt, nickel and copper sulphide concentrate by-product from Gabanintha.

Consequently, an initial Inferred Mineral Resource of 12.5 Mt at 206 ppm Co, 659 ppm Ni and 222 ppm Cu was estimated during the year. See table below:

Pre-Feasibility Study (PFS)

PFS work has been ongoing throughout the year, with a base case released during September 2018. The Company is evaluating both traditional and non-traditional processing routes as it looks to maximise the value of its world class Iron-Titanium-Vanadium resource at Gabanintha. The PFS is planned for completion by December 2018.

Negotiations have been held with the relevant Native Title party in respect to the Gabanintha mining lease application, M51/878. These negotiations have reached the stage where the Company has prepared a draft mining agreement for consideration by the Native Title party. Having recently concluded a similar mining agreement in respect to the nearby Nowthanna Hill mining lease, the Company believes that negotiations in respect to the Gabanintha mining lease can be successfully concluded.

Environmental studies

Throughout 2017, the Company and its environmental consultant completed flora, fauna and subterranean fauna baseline studies covering both autumn and spring seasons over the Gabanintha mineral resource area and the surrounding environments, which are most likely to be affected by future mining and processing activities.

Detailed reporting from these studies were concluded during the year and form an essential part of submissions for the regulatory approvals process. .

Vanadium experts appointed

During the year AVL built a team of world class professionals to advance the Gabanintha Project. Key appointments were:

- Non-Executive Director, Daniel Harris was appointed as Technical Director for the project.
- Todd Richardson, who has been appointed as Project Manager to drive the PFS;
- Wood Mining and Metals, led by Principal Engineer Brian McNab, who were appointed as the primary contractor for the PFS.

The depth of knowledge and experience in the vanadium sector that these expert appointments bring provides AVL with a leading edge in the vanadium exploration space.

Vanitec

The Company continues to actively participate in this important vanadium industry group. Mr Harris and Mr Algar have both attended Vanitec conferences during the reporting period. Mr Algar is a member of the Vanitec Energy Storage Committee.

Win-Win Development Group Agreement

The Company announced in June 2018 that it had signed a Memorandum of Understanding (MOU) with Chengdu based, Chinese steel and alloy product company Win-Win Development Group. The agreement provides an understanding between the two companies to further discussions around project finance and purchase of vanadium for steel strengthening. Win-Win is currently building a 5,000 tonnes per annum (tpa) vanadium carbon nitride (VCN) production line which requires approximately 7,000-8,000tpa of 98% V_2O_5 . The first stage will require 2,000-3,000tpa and be operational in 2019 and the second stage is planned for the following year. Win-Win has a shareholding in an operating production line currently producing 2,400tpa of VCN products for existing steel companies.

VSUN Energy

VSUN Energy Pty Ltd is a 100% owned subsidiary with the sole focus of the development of the Australian market for vanadium flow batteries.

Vanadium Redox Flow Battery

VSUN Energy's initial installation of a 10kW-100kWh VRB at a native tree nursery in Busselton, Western Australia has been performing as expected since October 2016. Despite some cloudy periods where less solar energy was generated, the site has not needed to take power from the grid during this period, meaning that it has in effect been providing an off-grid solution.

VSUN Energy continues to market commercial vanadium energy storage systems suitable for business and stand-alone microgrids through to utility scale opportunities. During the period the Company continued its marketing activity and advanced a number of leads to proposals and detailed review prior to approval.

Residential VRFB

During the period, VSUN Energy commissioned a strategic analysis of the residential battery market. The results highlighted that the VRB has significant points of difference from other forms of residential energy storage, including number of hours of energy stored, cycling robustness and non-flammability.

VSUN Energy has been working with SCHMID Energy Systems in Germany on the supply of a domestic scale VRFB system. Work is ongoing to ensure compliance with Australian standards for grid attached installations. This mainly involves integration of the BMS (Battery Management System) with Australian approved inverters. Consequently, at this stage installation of VRFB is restricted to off-grid settings only.

The base model Everflow VRFB system is a 5kW/15kWh unit, which supplies 5kW of power with 15kWh of energy storage, providing 3 hours at a constant load of 5kW. In typical Australian residential environments, this system will provide 4-8 hours of energy.

Laboratory Scale Vanadium Flow Cell Constructed

VSUN Energy personnel have constructed a laboratory scale vanadium flow cell for electrolyte testing and demonstration purposes. This work will allow VSUN Energy to easily verify the quality and performance of electrolyte prepared in its pilot plant. The Company is now able to scale up the test to use a larger commercial stack configuration. The aim being to continue to grow the Company's expertise in both electrolyte and battery construction.

Coates Project

The Coates vanadium deposit is situated approximately 35km east of metropolitan Perth in the Shire of Wundowie. Exploration at Coates was undertaken in the 1970s after its discovery in the early 1960s. Mining plans have previously been produced by Agnew Clough Ltd on the Coates vanadium deposit, although no significant mining was undertaken. Previous metallurgical testwork produced favourable results and the Company will investigate the viability of developing the site. During the period, AVL's exploration licence over the Coates vanadium deposit was granted.

Nowthanna Hill Project

During the year, following the successful negotiation of a mining project agreement with the Yugunga-Nya people, mining lease M51/771 was granted in August 2017. No field work has been undertaken since the lease was granted due to the exclusion of uranium as a condition of the mining lease approval. The Company has initiated a JORC 2012 Compliant Resource estimation for Uranium and Vanadium at Nowthanna.

Blesberg Project

The Blesberg Project is located approximately 80km north of Springbok in the remote Northern Cape Province of South Africa. It lies at the western end of the Northern Cape Pegmatite Belt. This belt extends from Vioolsdrif in the west for about 450 km towards the east. The deposit is one of the largest known economically mineralised and exploited pegmatite deposits in the Pegmatite Belt. Mining at Blesberg commenced in 1925. The main products from later mining were beryl, bismuth, tantalite-columbite, spodumene, feldspar and mica. Feldspar production from the mine was reported to be of very high quality, with the feldspar being pure white and unstained by iron oxide.

AVL's objective at Blesberg is to assess the value of any Lithium-Caesium-Tantalum (LCT) pegmatites present there, including the volume of ceramic grade feldspar and of high value by-products of spodumene, beryl and tantalite. During 2017, the Company completed 41 holes (3,128m) of Reverse Circulation (RC) drilling under the targeted budget requirements (see ASX announcement dated 23 November 2017). The programme was designed to achieve a drill intersection spacing of 50m, sufficient to allow good resolution of the pegmatite geometry and mineral distribution.

Drilling results confirmed the extension of the pegmatite beyond the historical mine particularly to the west under shallow cover, amenable to simple open cut methods. Lithium, beryl and tantalum minerals were identified in drill cuttings. However, assays of these minerals in drilling were disappointing overall and indicate that the Blesberg pegmatites are highly zoned. Beryl, spodumene and tantalum mineralisation occurs in intense, but isolated areas along the drilled length of the pegmatite body.

The high purity of the large crystalline feldspars observed in drilling support a feldspar focus at Blesberg, including the possibility of by-product extraction of lithium, beryl and tantalum minerals. Samples from the drilling and existing excavation are being collected to complete first-pass, low-cost metallurgical recovery tests. Confirming the recovery of a significant portion of the high-quality feldspar is central to any future development of the project.

The Company is proceeding to calculate and report a mineral resource estimate in accordance with the 2012 JORC Code as part of its agreement with the project vendors.

Earn-In Deal Renegotiated

Following the receipt and analysis of the results at Blesberg, the company has concluded that there is only localised development of low-grade LCT mineralisation. The drilling has, however, identified extensive pegmatite development containing a high quality and proportion of glass/ceramic quality feldspar. Since the value proposition of the project has changed significantly compared to the original earn-in deal, which was centred on lithium and tantalum mineralisation, AVL suspended the remainder of the cash payments of USD750,000 due under the agreement to the vendors of Southern African Tantalum and Lithium Mining Pty Ltd (SALT) and renegotiated an agreement that more accurately represents the potential value of the project.

Bryah Resources Limited

During the year, AVL invested \$500,000 and concluded a mineral rights sale agreement with Bryah Resources Limited ("Bryah") which successfully listed on ASX in October 2017.

Under the mineral rights sale agreement, Bryah acquired the rights to all minerals except Vanadium/Uranium/Cobalt/ Chromium/Titanium/Lithium/Tantalum/Manganese & Iron Ore and commenced exploration for gold-copper in December 2017.

AVL presently hold 7.5 million shares and 1.25 million listed options (expiry 31 October 2020, exercise price \$0.30) in Bryah which represents a 13.31% holding in that company.

PLACEMENTS

During the year, AVL completed the following placements to raise a total of \$5,505,000 before costs:

- 50,000,000 million new shares were issued at a price of \$0.015/share with 1:1 (50 million) free attaching listed option (expiry 31/12/2018; exercise price \$0.02) on 7 August 2017, raising \$750,000 before costs;
- 67,000,000 million new shares were issued at a price of \$0.015/share with 1:1 (67 million) free attaching listed option (expiry 31/12/2018; exercise price \$0.02) on 15 September 2017, raising \$1,005,000 before costs, and
- 75,000,000 million new shares were issued at a price of \$0.04/share on 12 April 2018, raising \$3,000,000 before costs.

OPERATING AND FINANCIAL REVIEW

Operating Review

A review of operations for the financial year is contained within this Directors' Report. The consolidated loss after income tax for the financial year was \$2,486,071 (2017: \$2,077,633).

Financial Position

At 30 June 2018, the Group had cash reserves of \$5,152,782 (2017: \$1,524,171). The net assets of the Group have increased by \$5,121,171. The increase is largely due to the following factors:

- the conversion of 81,196,803 options into new shares, raising \$1,256,439;
- the completion of 4 placements, involving the issue of 242,000,000 new shares, to raise \$5,505,000;
- ongoing exploration and evaluation of the Gabanintha Vanadium and Blesberg Projects;
- advancement of the vanadium in energy storage strategy;
- incurring overheads and running costs consistent with operating a listed company; and
- remuneration of key management personnel essential to the continued success of the Group.

Dividends

No dividends were paid during the year and no recommendation is made as to dividends.

SIGNIFICANT CHANGES IN THE STATE OF AFFAIRS

Significant changes in the state of affairs of the Company during the financial year are detailed in the Company's review of operations. In the opinion of the Directors, there were no other significant changes in the state of affairs of the Company that occurred during the financial year under review not otherwise disclosed in this Annual Report.

No matters or circumstances have arisen since the end of the financial year which significantly affected, or may significantly affect, the operations of the Company, the results of those operations, or the state of affairs of the Company in subsequent financial years, other than as outlined in the Company's review of operations which is contained in this Annual Report.

LIKELY DEVELOPMENTS AND EXPECTED RESULTS

The Company will continue to pursue its principal activity of exploration and evaluation, and associated activities as outlined in the Company's review of operations. The Company will also continue to pursue other potential investment opportunities to enhance shareholder value.

REMUNERATION REPORT (AUDITED)

This report details the nature and amount of remuneration for each director and executive of Australian Vanadium Limited. The information provided in the remuneration report includes remuneration disclosures that are audited as required by section 308(3C) of the *Corporations Act 2001*.

For the purposes of this report Key Management Personnel of the Group are defined as those persons having authority and responsibility for planning, directing and controlling the major activities of the Group, directly or indirectly, including any director (whether executive or otherwise) of the parent company.

For the purposes of this report the term "executive" includes those key management personnel who are not Directors of the parent company.

Remuneration Committee

The full Board carries out the role and responsibilities of the Remuneration Committee and is responsible for determining and reviewing the compensation arrangements for the Directors themselves, the Managing Director and any Executives.

Executive remuneration is reviewed annually having regard to individual and business performance, relevant comparative remuneration and internal and independent external advice.

Remuneration Policy

The board policy is to remunerate Directors at market rates for time, commitment and responsibilities. The board determines payments to the Directors and reviews their remuneration annually, based on market practice, duties and accountability. Independent external advice is sought when required. The maximum aggregate amount of Directors' fees that can be paid is subject to approval by shareholders in a general meeting, from time to time. Fees for non-executive directors are not linked to the performance of the consolidated entity. However, to align Directors' interests with shareholders' interests, the Directors are encouraged to hold shares in the Company.

The Company's aim is to remunerate at a level that will attract and retain high-calibre directors and employees. Company Directors and officers are remunerated to a level consistent with the size of the Company.

The executive Directors and full-time executives receive a superannuation guarantee contribution required by the government, which is currently 9.5%, and do not receive any other retirement benefits. Some individuals, however, may choose to sacrifice part of their salary to increase payments towards superannuation.

All remuneration paid to Directors and executives is valued at the cost to the Company and expensed.

The Board believes that it has implemented suitable practices and procedures that are appropriate for an organisation of its size and maturity.

During the year the Company included a performance-based component of remuneration for the Directors.

Remuneration Structure

In accordance with best practice corporate governance, the structure of non-executive director and executive compensation is separate and distinct.

Non-executive Director Compensation

Objective

The Board seeks to set aggregate compensation at a level that provides the company with the ability to attract and retain directors of the highest calibre, whilst incurring a cost that is acceptable to shareholders.

Structure

The Constitution and the ASX Listing Rules specify that the aggregate compensation of non-executive directors shall be determined from time to time by a general meeting. An amount not exceeding the amount determined is then divided between the Directors as agreed. The latest determination approved by shareholders was an aggregate compensation of \$500,000 per year.

The amount of aggregate compensation sought to be approved by shareholders and the manner in which it is apportioned amongst Directors is reviewed annually. The Board considers advice from external consultants as well as the fees paid to non-executive directors of comparable companies when undertaking the annual review process. Non-Executive Directors' remuneration may include an incentive portion consisting of options, as considered appropriate by the Board, which may be subject to Shareholder approval in accordance with ASX Listing Rules.

Separate from their duties as Directors, the Non-Executive Directors may undertake work for the Company directly related to the evaluation and implementation of various business opportunities, including mineral exploration/evaluation and new business ventures, for which they receive a daily rate. These payments are made pursuant to individual agreement with the non-executive Directors and are not taken into account when determining their aggregate remuneration levels.

Executive Compensation

Objective

The entity aims to reward executives with a level and mix of compensation commensurate with their position and responsibilities within the entity so as to:

- reward executives for company and individual performance against targets set by appropriate benchmarks;
- align the interests of executives with those of shareholders;
- link rewards with the strategic goals and performance of the company; and
- ensure total compensation is competitive by market standards.

Structure

In determining the level and make-up of executive remuneration, the Board negotiates a remuneration to reflect the market salary for a position and individual of comparable responsibility and experience. Due to the limited size of the Company and of its operations and financial affairs, the use of a separate

remuneration committee is not considered appropriate. Remuneration is regularly compared with the external market by participation in industry salary surveys and during recruitment activities generally. If required, the Board may engage an external consultant to provide independent advice in the form of a written report detailing market levels of remuneration for comparable executive roles.

Remuneration consists of a fixed remuneration and a long-term incentive portion as considered appropriate. Compensation may consist of the following key elements:

- Fixed Compensation;
- Variable Compensation;
- Short Term Incentive (STI); and
- Long Term Incentive (LTI).

Fixed Remuneration

The level of fixed remuneration is set so as to provide a base level of remuneration which is both appropriate to the position and is competitive in the market. Fixed remuneration is reviewed annually by the Board having regard to the Company and individual performance, relevant comparable remuneration in the mining exploration sector and external advice.

The fixed remuneration is a base salary or monthly consulting fee.

Variable Pay - Long Term Incentives

The objective of long-term incentives is to reward Directors/executives in a manner which aligns this element of remuneration with the creation of shareholder wealth. The incentive portion is payable based upon attainment of objectives related to the director's/executive's job responsibilities. The objectives vary, but all are targeted to relate directly to the Company's business and financial performance and thus to shareholder value.

Long term incentives (LTIs) granted to Directors and executives are delivered in the form of options or performance rights. LTI grants to executives are delivered in the form of employee share options or performance rights. Options are issued at an exercise price determined by the Board at the time of issue. The employee share options generally vest over a selected period.

The objective of the granting of options or rights is to reward executives in a manner which aligns the element of remuneration with the creation of shareholder wealth. As such LTI's are made to executives who are able to influence the generation of shareholder wealth and thus have an impact on the Company's performance.

The level of LTI granted is, in turn, dependent on the Company's recent share price performance, the seniority of the executive, and the responsibilities the executive assumes in the Company.

Typically, the grant of LTIs occurs at the commencement of employment or in the event that the individual receives a promotion and, as such, is not subsequently affected by the individual's performance over time.

Employment contracts of directors and senior executives

The employment arrangements of the non-executive chairman and executive directors are not formalised in a contract of employment.

Remuneration and other terms of employment for the Chief Executive Officer/Managing Director are formalised in an employment contract. Major provisions are set out below.

Vincent Algar, Managing Director:

- Annual base salary of \$250,000 plus superannuation
- Notice period required to be given by the Company or employee for termination of one month, except in the case of gross misconduct
- Payment of termination benefit on termination by either party equal to the amount in lieu of the notice period

- 21,000,000 performance rights (granted on 12 July 2017) that will each convert into one ordinary share upon the satisfaction of the following milestones:
 - (a) In respect to one-third of the Performance Rights, upon certification by an independent competent person, on or before 19 December 2019, of a JORC Reported resource or reserve on the Blesberg Lithium-Tantalum Project of 2,000,000 tonnes at a grade of at least 0.8% Li2O or Lithium equivalent in Beryl, Feldspar of Tantalum (reported in accordance with clause 50 of the JORC Code); and
 - (b) In respect to one-third of the Performance Rights, upon certification by an independent competent person, on or before 19 December 2020, of a JORC Reported resource or reserve on the Blesberg Lithium-Tantalum Project of 4,000,000 tonnes at a grade of at least 0.8% Li2O or Lithium equivalent in Beryl, Feldspar of Tantalum (reported in accordance with clause 50 of the JORC Code); and
 - (c) In respect to one-third of the Performance Rights, upon certification by an independent competent person, on or before 19 December 2021, of a JORC Reported resource or reserve on the Blesberg Lithium-Tantalum Project of 6,000,000 tonnes at a grade of at least 0.8% Li2O or Lithium equivalent in Beryl, Feldspar of Tantalum (reported in accordance with clause 50 of the JORC Code).
- 5,000,000 performance rights (expiry 2 February 2020, subsequently converted on 13 February 2018) that convert into one ordinary share upon the satisfaction of the following milestones:
 - (a) upon the Company releasing a Mineral Resource Statement containing a 2012 JORC Code Compliant Resource that includes Resources in the Measured Category; and
 - (b) the Company's shares trading at a volume weighted average market price of greater than 3.0 cents per share calculated over 20 consecutive trading days on which the Company's shares have actually traded.

The performance rights contain standard terms and conditions relevant to lapse of entitlement or right to conversion on cessation of employment.

Notes to the Financial Statements

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements and notes represent those of Australian Vanadium Limited (the "Company") and Controlled Entities (the "Consolidated Entity" or "Group") for the year ended 30 June 2018.

Australian Vanadium Limited is a company limited by shares incorporated in Australia whose shares are publicly traded on the Australian Securities Exchange. The Company is domiciled in Western Australia. The nature of operations and principal activities of the Group are described in the Directors' Report.

1(a) Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board (AASB) and the *Corporations Act 2001*. The Group is a for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. Material accounting policies adopted in preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The Group's financial statements are presented in Australian dollars.

1(b) Adoption of new and revised standards

In the current year, the Group has adopted all of the new and revised Standards and Interpretations issued by the Australian Accounting Standards Board (the AASB) that are relevant to its operations and effective for the current annual reporting period. The adoption of these new and revised Standards and Interpretations has not resulted in a significant or material change to the Group's accounting policies.

The Group has also reviewed all new Standards and Interpretations that have been issued but are not yet effective for the year ended 30 June 2018. As a result of this review the Directors have determined that there is no impact, material or otherwise, of the new and revised Standards and Interpretations on its business and, therefore, no change necessary to Group accounting policies.

1(c) Statement of Compliance

The financial report was authorised for issue on 28 September 2018.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions. Compliance with Australian Accounting Standards ensures that the financial statements and notes also comply with International Financial Reporting Standards (IFRS).

1(d) Basis of consolidation

The consolidated financial statements comprise the financial statements of Australian Vanadium Limited ("Company" or "Parent Entity") and its subsidiaries as at 30 June each year ("Consolidated" or "Group"). Subsidiaries are all entities over which the Group has control. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity.

Subsidiaries are fully consolidated from the date on which control is transferred to the Group and cease to be consolidated from the date on which control is transferred out of the Group. Investments in subsidiaries are accounted for at cost in the individual financial statements of Australian Vanadium Limited.

The financial statements of the subsidiaries are prepared for the same reporting period as the parent company, using consistent accounting policies.

In preparing the consolidated financial statements, all intercompany balances and transactions, income and expenses and profit and losses resulting from intra-group transactions have been eliminated in full.

1(e) Revenue and other income

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Group and the revenue can be reliably measured. The following specific recognition criteria must also be met before the revenue is recognised.

Interest revenue is recognised as it accrues, taking into account the effective yield on the financial asset.

1(f) Cash and cash equivalents

Cash comprises cash at bank and in hand. Cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

For the purposes of the statement of cash flows, cash and cash equivalents consist of cash and cash equivalents as described above, net of outstanding bank overdrafts.

1(g) Trade and other receivables

Trade receivables, which generally have 30-90 day terms, are recognised and carried at original invoice amount less an allowance for any uncollectible amounts. An allowance for doubtful debts is made when there is objective evidence that the Group will not be able to collect the debts. Bad debts are written off when identified.

1(h) Income Tax

Current tax assets and liabilities for the current and prior periods are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted by the reporting date.

Deferred income tax is provided on all temporary differences at the reporting date between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred income tax liabilities are recognised for all taxable temporary differences except:

- when the deferred income tax liability arises from the initial recognition of goodwill or of an asset or liability in a transaction that is not a business combination and that, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; or
- when the taxable temporary difference is associated with investments in subsidiaries, associates or
 interests in joint ventures, and the timing of the reversal of the temporary difference can be
 controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred income tax assets are recognised for all deductible temporary differences, carry-forward of unused tax assets and unused tax losses, to the extent that it is probable that taxable profit will be available against which the deductible temporary differences and the carry-forward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred income tax asset relating to the deductible temporary difference arises from the
 initial recognition of an asset or liability in a transaction that is not a business combination and, at
 the time of the transaction, affects neither the accounting profit nor taxable profit or loss; or
- when the deductible temporary difference is associated with investments in subsidiaries, associates or interests in joint ventures, in which case a deferred tax asset is only recognised to the extent that it is probable that the temporary difference will reverse in the foreseeable future and taxable profit will be available against which the temporary difference can be utilised.

The carrying amount of deferred income tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilised.

Unrecognised deferred income tax assets are reassessed at each reporting date and are recognised to the extent that it has become probable that future taxable profit will allow the deferred tax asset to be recovered.

Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply to the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

Income taxes relating to items recognised directly in equity are recognised in equity and not in profit or loss.

Deferred tax assets and deferred tax liabilities are offset only if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred tax assets and liabilities relate to the same taxable entity and the same taxation authority.

The amount of benefits brought to account or which may be realised in the future is based on the assumption that no adverse change will occur in income legislation and the anticipation that the Group will derive sufficient future assessable income to enable the benefit to be realised and comply with the conditions of deductibility imposed by the law.

1(i) Other taxes

Revenues, expenses and assets are recognised net of the amount of GST except:

- when the GST incurred on a purchase of goods and services is not recoverable from the taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable; and
- receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the taxation authority are classified as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the taxation authority.

1(j) Financial assets

Financial assets within the scope of AASB 139 Financial Instruments: Recognition and Measurement are classified as either financial assets at fair value through profit or loss, loans and receivables, held-to-maturity investments, or available-for-sale investments, as appropriate. When financial assets are recognised initially, they are measured at fair value, plus, in the case of investments not at fair value through profit or loss are directly attributable as transactions costs. The Group determines the classification of its financial assets after initial recognition and, when allowed and appropriate, reevaluates this designation at each financial year-end.

All regular purchases and sales of financial assets are recognised on the trade date i.e. the date that the Group commits to purchase the asset. Regular purchases or sales are purchases or sales of financial assets under contracts that require delivery of the assets within the period established generally by regulation or convention in the marketplace.

(i) Financial assets at fair value through profit or loss

Financial assets classified as held for trading are included in the category 'financial assets at fair value through profit or loss'. Financial assets are classified as held for trading if they are acquired for the purpose of selling in the near term. Derivatives are also classified as held for trading unless they are designated as effective hedging instruments. Gains or losses on investments held for trading are recognised in the statement of profit or loss and other comprehensive income.

(ii) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Such assets are carried at amortised cost using the effective interest method. Gains and losses are recognised in the statement of profit or loss and other comprehensive income when the loans and receivables are derecognised or impaired, as well as through the amortisation process.

(iii) Available-for-sale investments

Available-for-sale investments are those non-derivative financial assets that are designated as available-for-sale or are not classified as any of the three preceding categories. After initial recognition, available-for sale investments are measured at fair value with gains or losses being recognised as a separate component of equity until the investment is derecognised or until the investment is determined to be impaired, at which time the cumulative gain or loss previously reported in equity is recognised in profit or loss.

The fair value of investments that are actively traded in organised financial markets is determined by reference to quoted market bid prices at the close of business on the reporting date. For investments with no active market, fair value is determined using valuation techniques. Such techniques include using recent arm's length market transactions; reference to the current market value of another instrument that is substantially the same; discounted cash flow analysis and option pricing models.

1(k) Exploration and evaluation expenditure

Exploration and evaluation expenditures in relation to each separate area of interest are recognised as an exploration and evaluation asset in the year in which they are incurred where the following conditions are satisfied:

- (i) the rights to tenure of the area of interest are current; and
- (ii) at least one of the following conditions is also met:
 - (a) the exploration and evaluation expenditures are expected to be recouped through successful development and exploitation of the area of interest, or alternatively, by its sale; or
 - (b) exploration and evaluation activities in the area have not, at the reporting date, reached a stage which permits a reasonable assessment of the existence, or otherwise, of economically recoverable reserves and active and significant operations in, or relation to, the area of interest are continuing.

Exploration and evaluation assets are initially measured at cost and include acquisition of rights to explore, studies, exploratory drilling, trenching and sampling and associated activities and an allocation of depreciation and amortisation of assets used in exploration and evaluation activities. General and administrative costs are only included in the measurement of exploration and evaluation costs where they are related directly to operational activities in a particular area of interest.

Exploration and evaluation assets are assessed for impairment when facts and circumstances suggest that the carrying amount of an exploration and evaluation asset may exceed its recoverable amount. The recoverable amount of the exploration and evaluation asset (for the cash generating unit(s) to which it has been allocated being no larger than the relevant area of interest) is estimated to determine the extent of the impairment loss (if any). Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but only to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in previous years.

Where a decision has been made to proceed with development in respect of a particular area of interest, the relevant exploration and evaluation asset is tested for impairment and the balance is then reclassified to development.

1(I) Impairment of assets

The Group assesses at each reporting date whether there is an indication that an asset may be impaired. If any such indication exists, or when annual impairment testing for an asset is required, the Group makes an estimate of the asset's recoverable amount. An asset's recoverable amount is the higher of its fair value less costs to sell and its value in use and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets and the asset's value in use cannot be estimated to be close to its fair value. In such cases the asset is tested for impairment as part of the cash-generating unit to which it belongs. When the carrying amount of an asset or cash-generating unit exceeds its recoverable amount, the asset or cash-generating unit is considered impaired and is written down to its recoverable amount.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Impairment losses relating to continuing operations are recognised in those expense categories consistent with the function of the impaired asset unless the asset is carried at a revalued amount (in which case the impairment loss is treated as a revaluation decrease).

An assessment is also made at each reporting date as to whether there is any indication that previously recognised impairment losses may no longer exist or may have decreased. If such indication exists, the recoverable amount is estimated. A previously recognised impairment loss is reversed only if there has been a change in the estimates used to determine the asset's recoverable amount since the last impairment loss was recognised. If that is the case the carrying amount of the asset is increased to its recoverable amount. That increased amount cannot exceed the carrying amount that would have been determined, net of depreciation, had no impairment loss been recognised for the asset in prior years. Such reversal is recognised in profit or loss unless the asset is carried at a revalued amount, in which case the reversal is treated as a revaluation increase. After such a reversal, the depreciation charge is adjusted in future periods to allocate the asset's revised carrying amount, less any residual value, on a systematic basis over its remaining useful life.

1(m) Trade and other payables

Trade payables and other payables are carried at amortised costs and represent liabilities for goods and services provided to the Group prior to the end of the financial year that are unpaid and arise when the Group becomes obliged to make future payments in respect of the purchase of these goods and services.

1(n) Share-based payment transactions

The Group may provide benefits to employees (including senior executives) of the Group in the form of share-based payments, whereby employees render services in exchange for shares or rights over shares (equity-settled transactions).

When provided, the cost of these equity-settled transactions with employees is measured by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by an external valuer using a Black-Scholes model.

In valuing equity-settled transactions, no account is taken of any performance conditions, other than conditions linked to the price of the shares of Australian Vanadium Limited (market conditions) if applicable.

The cost of equity-settled transactions is recognised, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled, ending on the date on which the relevant employees become fully entitled to the award (the vesting period).

The cumulative expense recognised for equity-settled transactions at each reporting date until vesting date reflects (i) the extent to which the vesting period has expired, and

(ii) the Group's best estimate of the number of equity instruments that will ultimately vest.

No adjustment is made for the likelihood of market performance conditions being met as the effect of these conditions is included in the determination of fair value at grant date. The amount charged or credited to the statement of profit or loss and other comprehensive income for a period represents the movement in cumulative expense recognised as at the beginning and end of that period.

No expense is recognised for awards that do not ultimately vest, except for awards where vesting is only conditional upon a market condition.

If the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payment arrangement, or is otherwise beneficial to the employee, as measured at the date of modification.

If an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. However, if a new award is substituted for the cancelled award and designated as a replacement award on the date that it is granted, the cancelled and new award are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect, if any, of outstanding options is reflected as additional share dilution in the computation of earnings per share.

1(o) Issued capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

1(p) Segment Reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. The chief operating decision maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Board of Directors of the Company. The Group operates in two segments, being mineral exploration within Australia and the sale of VRB systems.

1(q) Earnings per share

Basic earnings per share is calculated as net profit attributable to members of the parent, adjusted to exclude any costs of servicing equity (other than dividends) and preference share dividends, divided by the weighted average number of ordinary shares, adjusted for any bonus element.

Diluted earnings per share is calculated as net profit attributable to members of the parent, adjusted for:

- costs of servicing equity (other than dividends) and preference share dividends;
- the after tax effect of dividends and interest associated with dilutive potential ordinary shares that have been recognised as expenses; and
- other non-discretionary changes in revenues or expenses during the period that would result from the dilution of potential ordinary shares; divided by the weighted average number of ordinary shares and dilutive potential ordinary shares, adjusted for any bonus element.

1(r) Investments in associates

An associate is an entity over which the consolidated entity has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

Investments in associates are accounted for in the parent entity using the cost method and in the consolidated entity using the equity method of accounting. Under the equity method, the investment in an associate is initially recorded at cost. The carrying amount of the investment is adjusted to recognise changes in the consolidated entity's share of net assets of the associate since the acquisition date. The consolidated entity's share of post-acquisition profits or losses is recognised in the statement of profit or loss and its share of post-acquisition movements in other comprehensive income is presented as part of the consolidated entity's other comprehensive income.

Unrealised gains or transactions between the Group and its associates are eliminated to the extent of the Group's interests in the associates. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of associates have been changed where necessary to ensure consistency with the policies adopted by the Group.

1(s) Plant and equipment

Plant and equipment is stated at cost less accumulated depreciation and any accumulated impairment losses.

Depreciation is calculated on a straight-line basis over the estimated useful life of the assets as follows:

Plant and equipment - 5 to 10 years

Motor vehicles - 8 years

The assets' residual values, useful lives and amortisation methods are reviewed, and adjusted if appropriate, at each financial year end.

(i) Impairment

The carrying values of property, plant and equipment are reviewed for impairment at each reporting date, with recoverable amount being estimated when events or changes in circumstances indicate that the carrying value may be impaired.

The recoverable amount of plant and equipment is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

For an asset that does not generate largely independent cash inflows, recoverable amount is determined for the cash-generating unit to which the asset belongs, unless the asset's value in use can be estimated to be close to its fair value.

An impairment exists when the carrying value of an asset or cash-generating units exceeds its estimated recoverable amount. The asset or cash-generating unit is then written down to its recoverable amount. Impairment losses are recognised in the statement of profit or loss and other comprehensive income.

(ii) Derecognition and disposal

An item of plant and equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal.

Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the statement of profit or loss and other comprehensive income in the year the asset is derecognised.

1(t) Significant Accounting Estimates and Judgments

Significant accounting judgments

In the process of applying the Group's accounting policies, management has made the following judgments, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements.

Exploration and evaluation assets

The Group's accounting policy for exploration and evaluation expenditure is set out at Note 1(I). The application of this policy necessarily requires management to make certain estimates and assumptions as to future events and circumstances. Any such estimates and assumptions may change as new information becomes available. If, after having capitalised expenditure under the policy, it is concluded that the expenditures are unlikely to be recovered by future exploitation or sale, then the relevant capitalised amount will be written off to the statement profit or loss and other comprehensive income.

Significant accounting estimates and assumptions

The carrying amounts of certain assets and liabilities are often determined based on estimates and assumptions of future events. The key estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of certain assets and liabilities within the next annual reporting period are:

(i) Impairment of assets

In determining the recoverable amounts of assets, in the absence of quoted market prices, estimations are made regarding the present value of future cash flows using asset-specific discount rates and the recoverable amount of the asset is determined. Value-in-use calculations performed in assessing recoverable amounts incorporate a number of key estimates.

(ii) Share-based payment transactions

The Group measures the cost of equity-settled transactions with employees by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined from market value.

Annual Mineral Resource Statement

1. GABANINTHA PROJECT - MINERAL RESOURCE STATEMENT

A summary of the Mineral Resources at the Gabanintha Project as at 30 June 2018 is shown in Table 1 below.

The updated Mineral Resource estimation was carried out Trepanier Pty Ltd, resulting in the estimation of Measured, Indicated, and Inferred Mineral Resources. All mineralised domains, are reported above 0.4% V_2O_5 for the low-grade ore zones and above 0.7% V_2O_5 within the high-grade zones.

The Mineral Resource estimate consists of:

- 175.5 million tonnes at 0.77% V₂O₅ containing 1.35 million tonnes of V₂O₅;
- discrete high-grade zones of 93.6 million tonnes at 1.00% V₂O₅ containing 936,000 tonnes of V₂O₅;
- discrete low-grade zones of 77.5 million tonnes at 0.50% V₂O₅ containing 384,000 tonnes of V₂O₅, and
- combined Measured and Indicated Mineral Resources of 34.1 Million tonnes at $0.77\% V_2O_5$ in low and high-grade zones containing 263,000t V_2O_5 .

There is no material change in the Mineral Resource Estimate between 2017 and 2018. The updated estimation represented a 2% decrease in the overall Resource, a 1% increase in the Measured Resource, a 5% decrease in the Indicated Resource and a 1.8% decrease in the Inferred Resource categories for the Project compared to the 2017 estimation.

The revised estimate was conducted following a review of the geological interpretation of the weathering profile and subsequent variation to density allocations for the Gabanintha mafic layered intrusion. Extensive consideration of geophysics and a review of the geological continuity along-strike and down-dip was also conducted.

The Group is not aware of any new information or data that materially affects the information as previously released and all material assumptions and technical parameters underpinning the estimates continue to apply and have not materially changed.
