

- The Australian share market declined 6.5% in October whilst the Small Ordinaries Accumulation Index had its worst performing month in over six years, off 9.6%.
- Our portfolio declined 6.4% and was largely impacted by our positions in energy stocks. Evolution Mining Limited (EVN.ASX) was the best contributor, its share price was up over 12% for the month.
- The portfolio cash level increased slightly to 8%.


