## CLEANSING STATEMENT

Ultima United Limited (ASX: UUL – the “Company” or “Ultima”) has issued and allotted 3,825,097 ordinary shares at an issue price of \$0.10 per share to sophisticated investors. Below is the applicable Cleansing Notice.

### Secondary Trading Exemption:
