Administrators' Appointment

We advise that earlier today the directors of the Companies resolved pursuant to section 436A of the Corporations Act 2001 (the Act) to appoint Martin Jones and Andrew Smith of Ferrier Hodgson as Joint and Several Voluntary Administrators of the Companies.

The Administrators are working with the directors in reviewing the Companies operations (which are currently the subject of care and maintenance) and financial position, including conferral with the Companies stakeholders to formulate potential strategies to preserve and restructure the Companies and its underlying operations.

Whilst the Companies are in administration the shares will be suspended. Shareholders are unable to transfer their shares during the administration without the consent of the Administrators or the Court.

Our immediate priority is to explore the opportunity to restructure the Companies in the short term. Due to the large number of shareholders, corresponding individually with shareholders would be a time-consuming process that could detract efforts to focus on the immediate priority of restructuring the Companies. In this regard, further shareholder updates in respect of the Companies will be posted to the ASX platform in due course. We appreciate shareholders' patience through the administration in the interim.

2018 AGM

We note that the 2018 AGM was ordinarily required to be held on 30 November 2018. Given our appointment as Administrators, the 2018 AGM will no longer be held as proposed.
