



#### **RC** drilling at the Light of Asia mine north of Cue




## **PROVEN GOLD REGION**

#### Day Dawn trend (1.7Moz)




- 400m x 400m gravity survey covering the entire Cue Project

#### **CUE - 2D SEISMIC view looking to the north east**




Structural targets identified – drilling underway



### Strategic tenement holding




