

CLEANSING NOTICE NOTIFCATION UNDER SECTION 708A(5)(E)

On 4 December 2018 NTM Gold Ltd ("**NTM**" or "the **Company**") issued 8,113,433 fully paid ordinary shares (the **Shares**) to Ausdrill Limited. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 4th of December 2018.

The Company gives notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) that:

- 1. The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- 2. The Company, as at the date of this Notice, has complied with:
 - (a) the provisions of Chapter 2M of the Act as they apply to the Company; and

 - (b) investors and their professional advisors would reasonably require for the purpose of making an informed assessment of:
 - the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - the rights and liabilities attaching to the Shares.
