## **PRO-RATA OFFER OF NEW OPTIONS**

- Pro-rata issue of new options to Elixir shareholders at the ratio of 1 new option for every 4 shares held
- New options issued at 1 cent each and exercisable at 7.5 cents on or before 31 December 2020

**Elixir Petroleum Limited (ASX:EXR)** is pleased to announce that it has today lodged a Prospectus with the Australian Securities & Investments Commission for the raising of up to approximately \$961,908 (before costs) through a non-renounceable, pro-rata offer of new options. Each option will be exercisable at \$0.075 on or before 31 December 2020 (**New Options**) with an issue price of \$0.01 per option and will be available to all eligible shareholders on the basis of one (1) New Option for every four (4) shares held on the record date (**Offer**). The Offer is not underwritten.

The Company will apply to ASX for quotation of the new options on the official list of ASX.

The record date for determining entitlements to New Options under the Offer is 5pm (WST) on 21 December 2018. Eligible shareholders will be holders as at the record date whose address in the Company's register is in Australia or New Zealand. As the Offer is non-renounceable, the rights may not be transferred or sold. Up to approximately 96,190,808 New Options will be issued pursuant to the Offer.

The funds raised under the Offer will be used to supplement the Company's existing cash reserves and will be used to fund further exploration work on the Company's existing assets, provide general working capital and, if the acquisition of Golden Horde Ltd completes (which is expected to occur later today), to fund further activities within the Nomgon IX CBM PSC.
