LRC042:

New drill results extend NdPr mineralisation at Longonjo with broad, high-grade intersections starting from surface

Pensana Metals Ltd (ASX: PM8) is delighted to report further excellent drill results from its exploration programme at the Longonjo NdPr Project in infrastructure rich Angola.

Results from the latest 31 holes include a number of high-grade intersections starting from the surface up to 42 metres in thickness.

These results follow on from the previously announced results which also included high-grade intersections starting from surface and up to 65 metres in thickness. A number of these deeper intersections remain open at depth.

With just over half of the results reported the mineralisation has been extended in all directions and remains open.

Results from 67 of the 108 holes drilled have extended the area of the Mineral Resource estimate by several hundred metres to the north, east and the west.

The mineralisation appears to have been closed off to the north but remains open in all other directions with broad, high-grade intersections reported at either end of the east-west drill line.

The mineralisation occurs as a weathered blanket, up to 65 metres in thickness, draped across the top of the 3.8 square kilometre carbonatite intrusion.

The results expected shortly from the 41 holes drilled in the 2,200 by 900 metre southern area of the carbonatite are expected to further extend the mineralisation.

Executive Director Dave Hammond commented:

"These broad intersections of high-grade mineralisation from surface are exceptional and they follow on from similar intersections reported in earlier holes.

With just over half of the drill results received to date it's clear that much of the weathered blanket covering the 3.8 square kilometre carbonatite is mineralised and that we are already looking at the potential for a very substantial expansion of the maiden Mineral Resource estimate.

We are eagerly anticipating the results from the remaining 41 holes in the untested southern area, which has considerable potential to add further extensions to the mineralisation.

Once all the results have been received, we look forward to reporting an upgraded Mineral Resource estimate early in 2019."

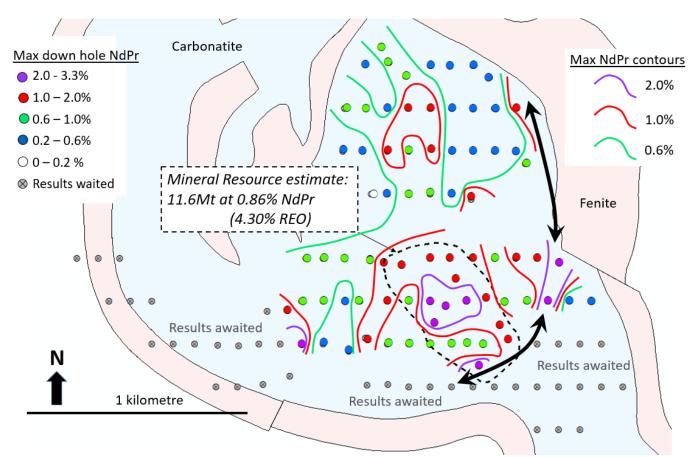
Technical Report

The 4,206 metre reverse circulation programme is testing an area ten times that of the maiden Mineral Resource estimate (11.6 million tonnes at 4.30% REO including 0.86% NdPr, ASX announcement 26 September 2017), with a view to generating an upgraded Mineral Resource estimate.

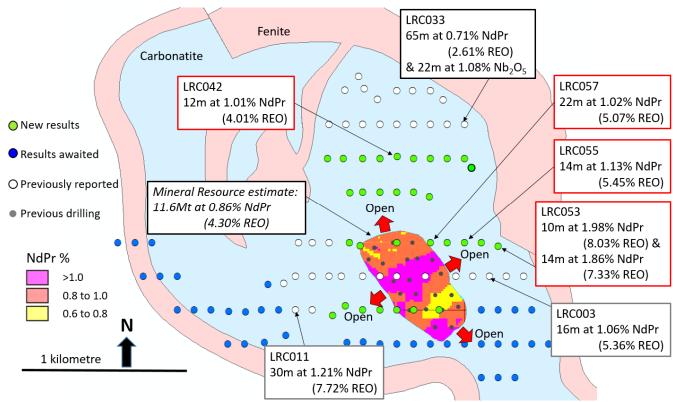
The latest results from 31 wide spaced vertical holes have returned particularly high-grade intersections from surface up to 10 metres at 8.03% REO including 1.98% NdPr from surface and 14 metres at 7.33% REO including 1.86% NdPr from 20 metres in the same drill hole, LRC053.

As well as extending the continuous zone of high-grade mineralisation in the maiden Mineral Resource estimate area several hundred metres to both the east and west, results received to date have identified a new high grade zone in the west and another along the eastern margin of the carbonatite.

Broad intersections from surface were also returned from the northern area.



Maximum downhole NdPr plan demonstrates that high grade, near surface NdPr mineralisation extends well beyond the maiden Mineral Resource area at Longonjo.



Location of new drill results with respect to the maiden Mineral Resource estimate and the extent of the prospective Longonjo Carbonatite. Results from a further 41 drill holes are expected over the coming weeks.

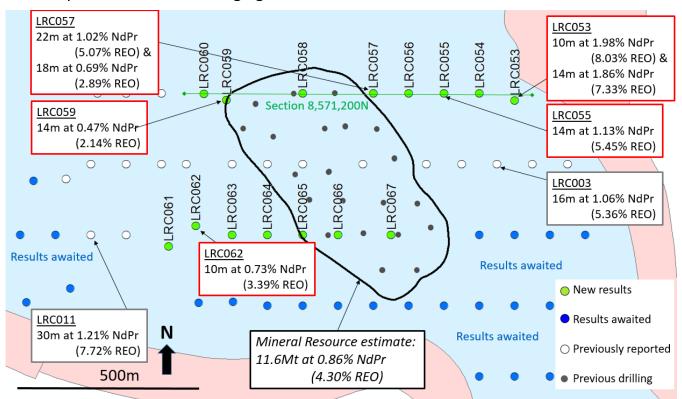
The new results demonstrate the widespread nature of near surface NdPr mineralisation across the carbonatite and that is particularly enriched in the weathered zone. High grade intersections at a 0.40% NdPr grade cut include:

The highest grades returned from the new results (LRC053) are located in the south of the project, 400 metres to the east of the limits of the current Mineral Resource area, on the eastern end of the drill traverse.

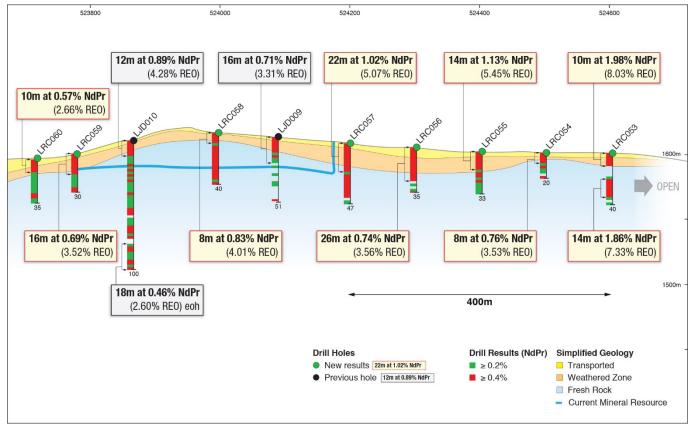
The grades of mineralisation intersected in this previously untested area compare well to the average grades of the current Mineral Resource estimate.



Above: Plan of intersection highlights from the new drilling results (red labels, green drill hole collars) in the southern area of the project. The majority of intersections start at surface (see Table 1). High grade mineralisation has now been identified 400m to the east and 600m west of the limits of the maiden Mineral Resource. Mineralisation remains open to the east, west and south, where results are expected shortly.

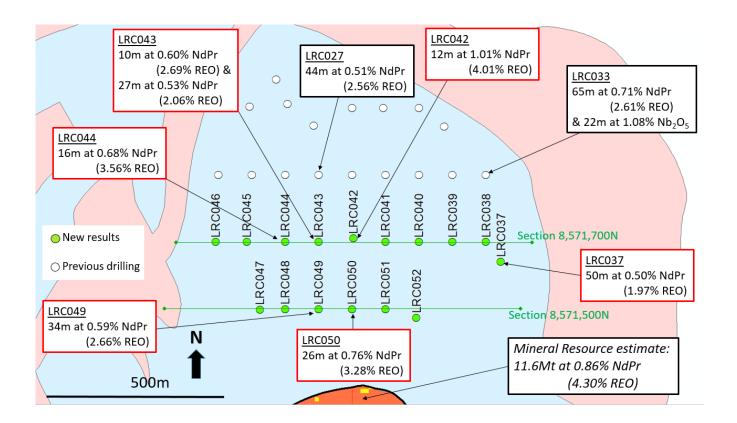
High grade mineralisation has now been identified over a total width of 1,250 metres and remains open to the east, west and south, where results from drilling are awaited.

The following vertical drill section illustrates the continuous nature of the high grade blanket of near surface mineralisation to the east of the current Mineral Resource boundary.



Above: New assay results from section line 8,571,200N show high grade near surface mineralisation continues for a further 400m to the east of the limit of the current Mineral Resource estimate. Assay results from the previously untested northern part of the project, up to 800 metres north of the current Mineral Resource estimate, define a continuous central zone of mineralisation and an eastern zone of deeply weathered mineralisation up to 65 metres thick along the margin of the carbonatite.

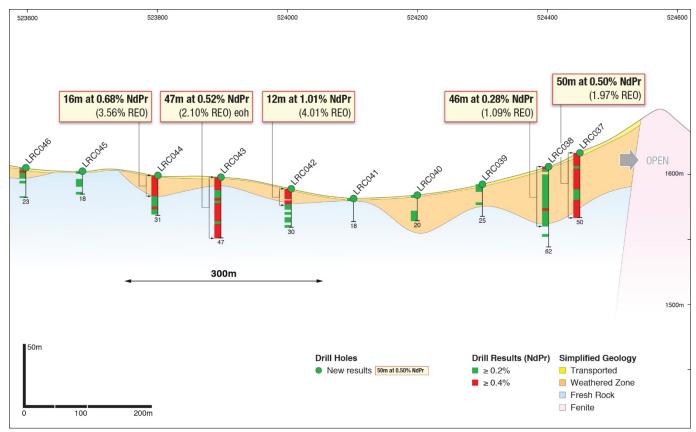


Plan of intersection highlights from the new drilling results (red labels, green drill hole collars) in the northern area of the project, which together with previously reported intersections (black labels, white collars) identify broad zones of NdPr mineralisation up to 600m to the north of the current Mineral Resource estimate. The majority of intersections start at surface (see Table 1).

The high-grade zone on the eastern margin of the carbonatite appears to be increasing in grade towards the contact with the fenite and may extend southwards into the southern part of the project (see first figure, this report).

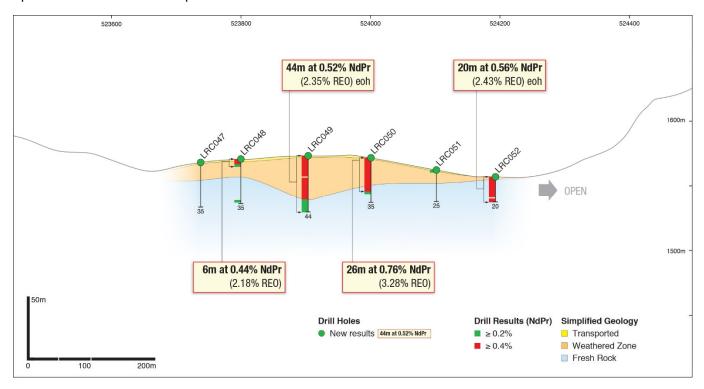
Assays from the remaining drill holes already completed, all located in the southern part of the project, will determine whether this high-grade zone continues along the southern margin of the carbonatite.

Fresh rock carbonatite hosted mineralisation was intersected by the northern drilling, and remains open to the east and with depth (see sections following).

The Company looks forward to reporting the assay results from the remaining 41 drill holes in January 2019.

Once the final assays are received, the Company plans to complete a revised Mineral Resource estimate for Longonjo. The successful delineation of a very large expanded NdPr Mineral Resource estimate would allow the Company to identify and select the most favourable, highest quality mineralisation for initial development studies.

Strategic Vision for Longonjo

Pensana Metals is completing studies for a distinctly different, low cost development approach for Longonjo and to determine the potential of the project to become a globally significant supplier of raw materials to the expanding magnet metal market - a market driven by the electrification of transport and the drive to green energy generation.

Longonjo is located only 4 kilometres from a modern rail line that leads directly into an Atlantic port. The potentially free dig, low waste to ore ratio and high grade nature of the surface mineralisation, together with its favourable location and transport infrastructure already in place distinguish Longonjo from other rare earth projects.

The Company's vision is to leverage these unique advantages with the aim to rapidly develop a relatively low capital intensive, low technical risk, conventional open pit mine and on site beneficiation plant to produce a high grade mineral product for export.
