ICM Limited acts as discretionary investment manager for Zeta Resources Limited (the 'Fund'). For the purposes of this report, ICM indicates the aggregated interest held by the fund. ICM does not itself own any securities of the issuer but exercises control or direction over certain securities of the issuer (as indicated in item 3.2 below) as the investment manager of the Fund.

The requirement to file this report was triggered on the 20th December 2018, when ICM, on behalf of the Fund, acquired 910,000 shares through open market transactions on the TSX.

Since the last report filed by ICM on the 18th May 2018, ICM, on behalf of the Fund, has acquired an aggregate 5,183,606 shares, representing 2.75% of the issuers 188,170,359 issued and outstanding Shares, as reported by the issuer in its Third Quarter Report 30 September 2018 ('Outstanding Shares').

As at the end of December 2018, ICM, on behalf of the fund, exercised control and direction over an aggregate of 24,139,647 shares, representing approximately 12.83% of the issued and outstanding shares of the company.


