COMPLETION OF PLACEMENT AND MOBILISATION OF EQUIPMENT TO LAKE WAY

Salt Lake Potash Limited (**the Company** or **SO4**) is pleased to announce that it has now completed the second tranche of its previously announced placement of 31.0 million new ordinary shares of the Company, to raise gross proceeds of \$13,000,000 (**Placement**).

The second tranche of the Placement was completed today following shareholder approval at a General Meeting held on 20 December 2018. The issue comprised 1.7 million shares, including 950,000 shares subscribed for by the CEO, Mr Tony Swiericzuk, and 750,000 shares by the Company's Chairman, Mr Ian Middlemas.

Proceeds from the Placement will be used to fund the construction of the Williamson Ponds and dewatering of the Williamson Pit, as well as ongoing development of on-lake infrastructure, exploration and feasibility studies, and general working capital.

The completion of the Placement has enabled the mobilisation of construction equipment to Lake Way, with preliminary site preparation works being undertaken in preparation for the imminent construction of the Williamson Ponds and dewatering of the Williamson Pit.
