Orcoda and Minset Sign Mine Shutdown Deal

Orcoda Limited (ASX: ODA) ('Orcoda' or 'the Company'), the logistics optimisation company working in the resources, healthcare, and transport sectors, is pleased to announce that its Resource Logistics Division has signed a service supply agreement with Minset Pty Ltd ("Minset") for a project which will commence on 22 January 2019 at a BHP mine. The service will take approximately a month to complete with revenue of \$35,000.

The project involves using Orcoda's management platform and processes, supported by the Minset team, to undertake a live planned maintenance shutdown on an operational mine. This live shutdown follows the recent successful execution of the previously announced trial mine shutdown service.

In this partnership with Minset, and in cooperation with the BHP inhouse maintenance team, Orcoda is implementing a real time, mine shutdown, which involves coordinating 350 subcontracted workers. The platform and process can be used to scale to other mines and maintenance schedules.

Andrew Attrill, Minset Director, said, "We are excited to be partnering with Orcoda to implement their digital products to optimise shutdowns. We know this will be an important evolution in improving shutdown performance across the resources industry."
