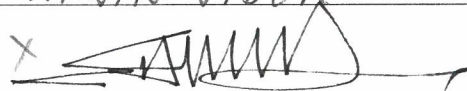

DIRECTIONS

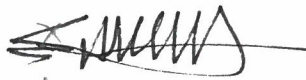
