



PLACEMENT OF RIGHTS ISSUE SHORTFALL

Alice Queen Limited (ASX: AQX) (AQX or the Company) is pleased to advise that it has received commitments for the placement of, and in response to those commitments has issued, 113,920,334 fully paid ordinary shares at \$0.015 (1.5 cents) per share to a combination of existing shareholders and new investors. The issue raised approximately \$1.7 million before costs.

The shares were issued as part of the shortfall of the Company's pro-rata entitlement offer (Rights Issue) made under a prospectus lodged with ASIC and released to ASX on 24 September 2018. As announced on 29 October 2018, the total shortfall under the Rights Issue was 114,119,529 fully paid ordinary shares.

Under its prospectus, the Company reserved the right to place any shortfall at the discretion of the Board within three (3) months after the closing date of the Rights Issue. The Rights Issue closed on 24 October 2018 and the Company has been seeking to place the shortfall since the closing date.

The Board of the Company would like to express their thanks for the support provided by participants in the Rights Issue and by participants in the shortfall.

The Company's securities will be reinstated to quotation upon release of this announcement.
