Argentine Project Update

During March quarter of 2018 ENB entered into a binding heads of agreement to acquire all the securities of Domingo Lithium Pty Ltd. Domingo Lithium has four prospective lithium permits. Two permits in Argentina in the San Luis region in application status, one permit in Western Australia in application status and one permit in NSW which has been granted. While progress was made in terms of furthering the grant of the permits the permits remained in an ungranted status as of the current date.

Voluntary Suspension

On December 10th, 2018 the company requested that its securities be suspended from trading due to a proposed capital raising. The company will remain in suspension until it has completed but the capital raising and recompiled with Chapters 1 & 2 of the listing rules. ENB expects to inform the market as soon as possible with full details of the proposed capital raising.
