Quarterly Activities Report to 31 December 2018

HIGHLIGHTS

- Hudbay JV on SUH's Llahiun Cu/Au Project in Chile progressing well
 - Hudbay commences drilling in Chile.

Southern Hemisphere Mining Limited ("Southern Hemisphere", "SUH" or "the Company") (ASX: SUH) is pleased to provide the following Quarterly Activities Report for the period ending 31 December 2018.

David Lenigas, SUH's Chairman, commented:

"Meetings with Hudbay in Canada recently give the board confidence that Hudbay are considering moving in to the second year of the earn in process on our 100% owned Llahuin Copper/Gold Project in Chile and they have confimed that they have drilled 3 diamond holes totalling 1413 metres. We look forward to report key exploration findings from Chile when available. Should Hudbay decide to move forward with their earn-in for 2019, which must be declared by 8 February, Hudbay will pay SUH another US\$250,000 by way of a cash payments for 2019 and commit to spending US\$1 million in exploration for the year."

Hudbay JV - Chile

Copper mining major, Hudbay Minerals Inc ("Hudbay"), the Company's Chilean Llahuin Copper/Gold Project earn-in and Joint Venture partner, advised the Company in November that they commenced drilling on the asset.

The Agreements between SUH and Hudbay, as announced to the market on 8 February 2017, provides a path for Hudbay Chile to earn a 70% interest in the Llahuin Project by making a series of cash payments to SUH (via SUH's 100% owned Llahuin) totalling US\$5.8 million over 5 years with the next payment of US\$250,000 due in February 2019, and committing to spend a minimum of US\$3.5 million on exploration work over the first 3 years (including the obligation to meet exploration covenants of \$500,000 in the first year, \$1,000,000 in the second year and \$2,000,000 in the third year).

Australian Gold Investments:

The company has been advised that post the 31 Decmber 2018 reporting period, that the Western Australian Government's DMIRS has granted E52/3579 on the 15th of January 2019.

E52/3579 has been granted for an initial term of 5 years, to expire on the 14th of January 2024. A single 5 year extension of term will be available prior to the expiry date, followed by multiple 2 year extensions of term.

The granted area of E52/3579 is 82 blocks – as this is more than 10 blocks in size, E52/3579 is subject to the 40% compulsory partial surrender requirement in year 6 of term (15/01/2024 to 14/01/2025).



Corporate

The Company raised A\$200,000 through a placement of 3.33m shares at \$0.06 to sophisticated investors. The funds will be used as general working capital.

Southern Hemisphere Mining Limited (ASX Code "SUH") is an experienced copper-gold explorer and developer. The Company has until recently been primarily focused in Chile, the world's leading copper producing country and one of the most prospective regions of the world for major new copper discoveries. In Chile, the primary areas of focus are on the Llahuin Porphyry Copper-Gold Project where the Company has drilled up a significant Copper Gold resource, and the Los Pumas Manganese Project. The Company is now beginning exploration on its new focus in the highly gold prospective areas of the southern Pilbara Basin in Western Australia.
