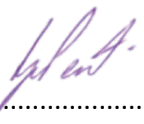

The company entered into a Loan Facility Agreement with Geopacific Resources Ltd (the Lender), the major shareholder of the company, on 19 December 2017 as announced on the ASX on 21 December 2017. The Loan Facility is for up to \$500,000, is unsecured and free from costs and interest, for 12 months period (maturing on 19 December 2018) and is convertible at the Lenders election at market pricing and subject to obtaining all regulatory approvals. The maturity date has been extended, by mutual agreement, to 19 February 2019.
