#### SECONDARY TRADING NOTICE

Collaborate Corporation Limited (ASX:CL8) (**Collaborate** or the **Company**) confirms that it has issued 3,535,714 fully paid ordinary shares (**Shares**) to a consultant at a deemed issue price of \$0.014 per Share in lieu of cash payment for services.
