Completion of Placement

Nexus Minerals Limited (the Company) (ASX: NXM) advises that it has completed the issue of 22,000,000 fully paid ordinary shares at a price of 5.7 cents each to raise \$1,254,000 (Placement). The funds raised in the Placement will be used to fund exploration including a RC drilling program on the Company's Wallbrook Gold Project and working capital.

13,200,000 shares have been issued pursuant to ASX listing rule 7.1 and 8,800,000 issued pursuant to ASX listing rule 7.1A.

Section 708A Notice

The shares issued are part of a class of securities quoted on the ASX Limited. The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act.

The securities are issued without disclosure to investors under Part 6D.2, in reliance on Section 708A(5) of the Corporations Act. The Company, as at the date of this notice, has complied with:

the provisions of Chapter 2M of the Corporations Act; and Section 674 and 675 of the Corporations Act.

Of the 22,000,000 shares issued in the Placement, 8,800,000 shares were issued pursuant to ASX listing rules 7.1A. The Company provides the following information as required under ASX listing rule 3.10.5A:

a) The dilution to existing shareholders at the time of the Placement as a result of the issue under ASX listing rule 7.1A was 9.94%.

b) The Company issued shares to sophisticated and professional investors as it was considered to be a more efficient mechanism for raising the funds for this Placement. The Placement did not expose the Company to the market volatility that it may have experienced over a more extended capital raising process such as a pro-rata issue. However, the Company is undertaking a Share Purchase Plan offering to existing eligible shareholders on the same terms as the Placement;

- c) No underwriting arrangements were in place for the Placement; and
- d) The Company paid commission of 6% on the amount raised in the Placement.
