Orcoda Resource Logistics Update

Orcoda Limited (ASX: ODA) ('Orcoda' or 'the Company'), the resources, healthcare, and transport logistics optimisation company, is pleased to provide a progress report on its Resource Logistics division:

Minset BHP Mine Shutdown - The Company is pleased to announce that its partnership with Minset on the shutdown at a BHP mine, previously reported to the ASX on 16 January 2019, was successfully completed on 13 March 2019. The Orcoda Management System (OMS) platform enabled BHP to ensure all contractors were fully compliant and efficiently mobilised to and from the mine site. The value of the contract was \$39k. Numerous Australian BHP mines are suitable to utilise the OMS solution and many other mines across Australia are likely to adopt this solution. Typically, mine shutdowns occur multiple times per year at each mine.

Andrew Attrill, Minset Director, said, "We are excited to be partnering with Orcoda to implement their digital products to optimise shutdowns across mines that we work on. We know this is an important evolution in improving shutdown performance across the resources industry, and we were impressed at the Orcoda Management System digital platform's ability to deliver the outcomes required and to improve efficiency on the recent shutdown at a BHP mine."
